

Approval to Purchase Three Squad Cars:

The Village Board approved a staff request to purchase two Dodge Durango pursuit vehicles and one Dodge Ram pursuit vehicle under the Southwest Conference of Mayors Cooperative in the amount of \$84,296 using DUI Tech Funds.

West Branch/Fair Oaks Road Bike Path - Advice of Supplement #2 for Engineering Services:

This agenda item is to advise the Board of an increase to the contract in the amount of \$3,449.33 due to work beyond the original scope and no Village Board action is required.

Motion to Approve Independent Contractor Agreements for Snow Plow Services: The Village Board approved independent contractor agreements with five snowplowing contractors (S & S Maintenance, John Tautges Trucking, AJD Construction & Concrete, U.S. Paving and D & M Services) for snow plowing services throughout the winter season.

Motion to Award a Contract for Installation of Lights at PWC and WRC:

The Village Board approved a contract with Jasco Electric Corporation in the amount of \$33,598 for installation of new site lighting with energy-efficient lights at the Public Works Center and the Water Reclamation Center.

Report of Officers:

Trustee Gieser congratulated Jim Knudsen on his 25 years with the Village and that it has been a pleasure working with him. He stated the Carol Stream Parade Committee lost a longtime volunteer and friend last week and we will all miss Sue Hudson.

Trustee Frusolone congratulated Jim Knudsen for 25 years of service to the Village and for explaining technical issues and laymen terms. She commented one of the items on tonight's agenda is for the purchase of 3 police vehicles. She stated she was very impressed that the Village gets their money out of their squad car purchases before deciding to purchase new vehicles and that we are using DUI funds to purchase the vehicles. Jersey Mike's Sandwich Shop recently opened on Army Trail Road in Bloomingdale and held a fund raising event in advance of their grand opening for the

Carol Stream Parks Foundation and the Glenbard North Athletic Booster's Association. She thanked Jersey Mikes for picking the 2 Carol Stream charitable organizations. Trustee LaRocca congratulated Jim Knudsen on his 25 years of service to the Village. He stated his thoughts and prayers were with the individuals who suffered the tragedies in Illinois and Philippines. He encouraged anyone who is able to contribute to the Red Cross to support the victims of the disasters.

Trustee Weiss commented that recent elected officials representing the Village in Springfield have local government backgrounds, which is critical to getting our voice heard. He stated West Chicago High School District 94 students are drafting mock legislation as part of their senior American government class. Next Wednesday he along with Mayor Saverino will be attending the next part of this process where the students take their draft legislation to the full body. He wished everyone in the community a happy Thanksgiving.

Trustee McCarthy congratulated Jim Knudsen for his years of service to Carol Stream and commented that over the past several Board meetings the Village Board has been recognizing long term employees which speaks to the stability and knowledge of our staff. Armstrong Park Flood Control Projects – First Amendment to the Intergovernmental Agreement (IGA) Between the County of DuPage, Illinois, Village of Carol Stream, Illinois and the Carol Stream Park

District for the Design of Various Public Improvements

On June 20, 2011 the Village Board approved Resolution No. 2539 approving an intergovernmental agreement (IGA) between DuPage County, the Village and the Carol Stream Park District for the design of various public improvements. Those improvements consisted of a flood control reservoir, pump station, elevating ball fields, repaving paths, providing flood plain compensatory and detention storage and other miscellaneous improvements all to be designed and constructed in Armstrong Park as well as a siphon outfall via Indianwood Drive to Klein Creek. That agreement called for the park District to retain ownership of the land where the flood control facilities were going to be constructed.

Since then the County has designed the projects and made applications to various agencies for permits. One permit, the Illinois Department of Natural Resources Office of Water Resources (IDNR-OWR) dam safety permit, required the owner of the land to accept liability and maintenance responsibilities for the flood control improvements. Those terms were beyond the Park District's capability and posed a liability burden.

The Park District is willing to transfer ownership and the County agreed to accept ownership of the land. The attached resolution amends the original IGA allowing for this transfer of ownership. The amendment has been reviewed by Staff and the Village Attorney and found to be acceptable. Therefore, we recommend the Village Board approve the IGA amendment.

FIRST AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT
BETWEEN THE COUNTY OF DUPAGE, ILLINOIS,
THE VILLAGE OF CAROL STREAM, ILLINOIS AND THE
CAROL STREAM PARK DISTRICT FOR THE
DESIGN OF VARIOUS PUBLIC IMPROVEMENTS

WHEREAS, pursuant to their respective grants of statutory authority the County of DuPage ("County"), the Village of Carol Stream ("Village") and the Carol Stream Park District ("Park District") entered into an Intergovernmental Agreement relating to the design and construction of stormwater management and flood control improvements at Armstrong Park, Carol Stream, Illinois (the "Project"); and

WHEREAS, due to engineering considerations, the Project's improvements need to be located, in part, on two parcels currently owned by the Park District as identified in the Intergovernmental Agreement, (also referred to as the "Agreement"), which Agreement was duly adopted by the DuPage County Board by Resolution SM-0012-11; and

WHEREAS, the Parties have determined that for the purpose of application to the Illinois Department of Natural Resources ("IDNR"), and for the public purposes related to the Project, it is necessary and convenient for the COUNTY own, use, occupy and improve the land on which certain Project improvements are to be located; and

WHEREAS, the Park District agrees to convey all of its rights, interests and legal title in the property depicted and described in 'Group Exhibit "A" [the 'Dam Property'] to the County; and

WHEREAS, the County agrees to accept ownership of the Dam Property, including all rights, interests and title thereto for the public purposes provided by the Project; and

WHEREAS, the Local Government Property Transfer Act, (the "Act"), (50 ILCS 605/1 et seq.), authorizes the proposed transfer ownership of the Dam Parcel and the Parties agree that the enactment of this Amendment to the Agreement shall serve as the authoritative enactments, as defined in the Act, and that no

further enactments shall be necessary for this conveyance of the Dam Property; and

WHEREAS, Paragraph 7.1 provides that the Agreement may be amended by a written instrument approved and executed by each of the Parties; and

WHEREAS, the Parties each agree to amend the Agreement as set forth in the First Amendment attached hereto.

NOW, THEREFORE BE IT RESOLVED that the County Board hereby approves and accepts the attached First Amendment to the Intergovernmental Agreement between the Village of Carol Stream, Illinois, the Carol Stream Park District and the County of DuPage, Illinois, providing for the design of the Project; and

BE IT FURTHER RESOLVED that the Chairman of the DuPage County Board, or his designee(s), is hereby authorized and directed to execute the attached First Amendment to the Intergovernmental Agreement on behalf of the County of DuPage, together with any and all additional documents deemed necessary and prudent to carry out the activities contemplated therein; and

FIRST AMENDMENT TO INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY OF DUPAGE, ILLINOIS, THE VILLAGE OF CAROL STREAM, ILLINOIS AND THE CAROL STREAM PARK DISTRICT FOR THE DESIGN OF VARIOUS PUBLIC IMPROVEMENTS

For the reasons stated herein and upon mutual consideration, the sufficiency of which is agreed to be adequate, the Parties to the original Intergovernmental Agreement (titled in full above, hereinafter referred to as "Original IGA") passed on or about June, 2011 hereby amend the Original IGA as follows:

- 1. In order to provide the most appropriate application to the Illinois Department of Natural Resources ("IDNR"), and also in order to clarify who is the 'owner of the dam' both for said application and for the terms of the ongoing agreement(s) with IDNR, the Park District will convey all right, title and interest in the property depicted and described in Group Exhibit "A" [The 'Dam Property'] to the County. The County agrees to take ownership of the Dam Property.
- 2. The authority for the conveyance is the Local Government Property Transfer Act [50 ILCS 605/1 et seq.] The Park District is the 'transferor municipality' and the County is the 'transferoe municipality' as defined therein. The parties agree that the enactment of this Amendment to the original IGA shall serve as the authoritative enactments, as defined in the Local Government Property Transfer Act, and that no further enactments shall be necessary for this conveyance of the Dam Property.

Amendment to Ordinance 2013-06-30

Triple C Development/Zippy's Express Car Wash – 120 S. Gary Avenue

At their June 17, 2013, meeting, the Village Board adopted Ordinance 2013-06-30, which granted the zoning approvals necessary to allow for the development of a Zippy's Express Car Wash on the property at 120 S. Gary Avenue. Triple C Development's plan for the project included the purchase of 18,620 square feet of vacant land immediately west of the White Castle Restaurant to allow for a more functional site plan for the car wash. Since car washes are only allowed in the B-3 Service District, and since the property that Triple C Development wished to purchase from White Castle was zoned B-2 General Retail District, one of Triple C Development's requests was for the rezoning of the property to be acquired from White Castle to B-3 Service District. The Village Board unanimously approved the rezoning from B-2 to B-3.

As a precautionary measure in the event that the car wash development did not move forward, the ordinance approving the rezoning contained the following language: "The rezoning granted in Section 1 herein is specifically conditioned upon the Petitioner acquiring legal title to both parcels of property legally described in Section 3 herein within one hundred and eighty days of the date of this Ordinance. Should the Petitioner fail to acquire title to both parcels as required herein, the zoning on said Property shall revert back to B-2 General Retail District."

As explained in the attached letter from Mark Evans, Development Coordinator for Triple C Development, Triple C Development will not be able to acquire title to the parcels within 180 days of approval of Ordinance 2013-06-30, which will be December 14, 2013. The financing for the property acquisition is contingent upon receipt of a building permit for the car wash, and Triple C Development has not yet submitted a building permit application, as they are currently working on the storm water management design and final engineering plans. To prevent the zoning classification of the property from automatically reverting back to B-2 District, which would require Triple C to reapply for the zoning change, Mr. Evans is requesting an amendment to Ordinance 2013-06-30, to extend the time period for acquiring title to both parcels to one year, which would be June 17, 2014.

Staff has no objection to the request to extend the timeframe for Triple C Development to acquire title to the car wash development parcels to June 17, 2014. If the Village Board concurs, they should adopt Ordinance amending the timeframe provision of Ordinance 2013-06-30.

Dear Mr. Bastian:

Triple C Development, Inc. plans to develop a Zippy's Express Car Wash on the presently vacant lot at 120 S Gary Avenue and an approximately 20,000 square-foot adjoining parcel to be acquired from the White Castle Restaurant at 110 W North Avenue. Triple C Development, Inc. has received, per Ordinance No. 2013-06-30, approval for the lot split from the restaurant property, rezoning of that property from Zone B-2 to Zone B-3, and consolidation of that property with the property at 120 S Gary Avenue, which is presently zoned B-3 also. Triple C Development, Inc. also has received approval for a Special Use Permit to operate an Auto Laundry at the newly consolidated lot, and approval of our site plan and design concepts for the Gary/North Avenue Corridor overlay district.

As we have previously discussed, the above listed approvals were conditioned upon, among other things, our obtaining title to both affected parcels within 180 calendar days of the effective date of the Ordinance. We regret to say, however, that technical difficulties have severely delayed our building permit application. While we believe that we now have those issues resolved and will be able to submit a complete building permit application package to the Village within the next few business days, it will not be possible for us to obtain a building permit for our project in time to close on the purchase of the two properties within the 180-day time limit stipulated in the Ordinance. And while the Ordinance does not require us to have a building permit within the 180-day time limit, our financing approval for the purchase of the property and construction of the project requires

that we have all necessary permits in hand prior to the land closing. To that end, we respectfully request that the Village Board of Trustees amend Ordinance No. 2013-06-30 to extend the land closing deadline to June 17, 2014 so that we can complete the building permitting process and proceed with construction of the car wash without the need to re-apply for the re-zoning and special use permit.

We now estimate that we can obtain our building permit and close on the property by the first week of January, 2014, and break ground on the project as soon as weather and the availability of construction materials permits. Extending the land closing deadline to June 17, 2014 will allow ample time for the resolution of any future unforeseen difficulties with the design and permitting phase of the project, though we do not anticipate any at this time.

We sincerely appreciate your patient assistance as we continue to work toward our goal of constructing what we believe will be one of our finest car wash facilities yet.

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE 2013-06-30 OF THE VILLAGE OF CAROL STREAM TO ALLOW AN EXTENTION OF TIME WITHIN WHICH TO ACQUIRE PROPERTY

WHEREAS, on the 17th day of June, 2013, the Mayor and Board of Trustees adopted Ordinance 2013-06-30, approving a Special Use Permit to allow an Automobile Laundry in the B-3 Service District and a Zoning Map Amendment to rezone the property commonly known as 120 S. Gary Avenue, Carol Stream, Illinois, and legally described in said Ordinance 2013-06-30 (hereinafter referred to as the "Property"), from B-2 General Retail District to B-3 Service District; and
