The following is a brief description of those items approved on the Consent Agenda.

PUD Plan Major Modifications: 293-317 S. Schmale - Ord. 2010-04-18:

At their meeting on February 3, 2009, the Combined Plan Commission/Zoning Board of Appeals recommended approval of a revised plan a commercial planned unit development for 293-317 S. Schmale Road. On April 12, 2010, they recommended approval of a major modification of a PUD by approving special uses for a second drive-up service window and outdoor seating, subject to the conditions in the staff report. The Board concurred with the recommendation and adopted Ordinance 2010-04-18, AN ORDINANCE APPROVING MODIFICATIONS TO A FINAL PLANNED UNIT DEVELOMENT PLAN AND SPECIAL USES FOR A DRIVE-UP SERVICE WINDOW AND OUTDOOR SEATING –(293-317 S. SCHMALE ROAD).

Special Use Permit – 225 Westgate Drive - Ord.2010-04-19:

At their meeting on April 12, 2010, the Combined Plan Commission/Zoning Board of Appeals recommended approval of the Special Use for outdoor truck and trailer storage in accordance with the conditions in the staff report. The Board adopted Ordinance 2010-04-19, AN ORDINANCE GRANTING A SPECIAL USE FOR OUTDOOR ACTIVITIES & OPERATIONS – (225 WESTGATE DRIVE).

Amendment to Special Use Permit – 365 Village Drive – Ord. 2010-04-20:

At their meeting on April 12, 2010, the Combined Plan Commission/Zoning Board of Appeals recommended approval of the amendment of the special use to allow for the outdoor installation of the outdoor liquid nitrogen tank, nitrogen vaporizer and gas nitrogen tanks, subject to the conditions in the staff report. The Board concurred with the recommendation and adopted Ordinance 2010-04-20, AN ORDINANCE GRANTING AN AMENDMENT TO A SPECIAL USE FOR OUTDOOR ACTIVITIES AND OPERATIONS – (362 VILLAGE DRIVE).

Monday Night Hours - Reception Area:

The Board approved to discontinue the Monday night hours at the Reception area due to the greatly reduced use. The 5 p.m. to 7 p.m. hours will continue during the vehicle sticker registration time and end on September 1st.

Budget Transfers:

The Board approved budget transfers for Police and Community Development. The transfers do not increase the department's budgets or the total budgets.

Award of Contract – 2010 Flexible Pavement Project:

The Board approved an award of Contract to Plote Construction, Inc. at the bid unit prices submitted.

Award of Contract – 2010 Asphalt Rejuvenator Project:

The Board waived contract bidding and approved an award of contract for the 2010 Asphalt Rejuvenator Project to American Road Maintenance (formerly Midwest Tar Sealer Company) at the negotiated price not to exceed \$247,500.

Approve Purchase Orders for Professional Services – B&F:

The Board approved the purchase orders for consultant services for permit reviews, inspections and general code consulting as budgeted in FY10/11.

Write-Off of Uncollectible Receivables:

The Board approved the write-off of Uncollectible Receivables in the amount of \$2.876.50.



Beginning May 4, 2010, advertisements for the Village of Carol Stream's Police Officer recruitment will begin. This is a three (3) month process which includes advertisement, application review, written examination and interviews with a panel of Police personnel. This effort culminates into a hiring list from which Police Officers may be selected over the next three (3) years.

Historically, the Village receives a large number of applicants for this process. Unfortunately, many of these applicants fail to show up to the written examination, and of those that do, few make it to the Final Eligibility List. As an example, during the last testing cycle 466 candidates applied for the examination process, 308 showed up to the written examination, and 54 candidates appeared on the Final Eligibility List.

Unlike other types of recruitment, the Police Officer testing process has additional costs associated with it per applicant. Outside of the staff time and administrative fees involved with the process, a study guide is provided in preparation for the written examination. The Village is charged \$7.00 per study guide. In addition, the cost of the written examination is \$22.00 per candidate.

Given the present economy, it is likely the Village could see an even greater number of applicants this testing cycle. Due to the costs associated with the number of applicants in conjunction with the continual efforts to reduce expenditures, the concept of an application fee has been evaluated. Comparable communities were asked about this concept, with 65% (9 of 14) reporting a fee already in place. These fees ranged from \$10.00 to \$25.00, and aside from a minor increase in staff time to process the fee, all communities who have implemented an application fee reported positively about the concept.

Therefore, in an effort to off-set some of the costs associated with the testing process, in addition to deterring some potential applicants who may not truly be interested in becoming a Police Officer, it is recommended to implement a \$10.00 non-refundable application fee.

If approved, the minutes should reflect the following:

In the exercise of its home rule powers, I move that the Village of Carol Stream implement a Police Officer application fee of \$10.00 for each application submitted.

Uncompleted Retention Ponds

For several years the Village has been attempting to get the developer to establish the vegetation around the retention basins in the Central Park subdivision. These efforts have not been successful for several reasons. The subdivision security was inadvertently allowed to expire and the developer has not renewed the letter of credit. The developer has also experienced financial difficulty as a result of the collapse of the housing market and is unable to complete the work. And the commercial property owners have refused to accept ownership and eventual maintenance responsibility on one of the ponds.

Through several conversations with the developer the Village Attorney was able to get him to agree to pay for the work to establish the vegetation. This would be accomplished by not issuing a real estate property transfer tax stamp for the two remaining properties he owns and by recording a security interest against those properties until the cost for the Village performing the work has been reimbursed to us. The Village would be reimbursed with proceeds from the sale of the properties. The developer has agreed to this approach.

The Village Attorney is working with the commercial property owners to have them accept ownership and maintenance responsibility of the lot 8 retention basin. The residential homeowners association has agreed to these responsibilities once the vegetation has been properly established on the other two remaining ponds. They will also provide us with the sidewalk easements for our approval and recording.

The Village has requested and received a contract from Christopher B. Burke Engineering Ltd. (CBBEL) to repair the degraded basin slopes, enhance native vegetation establishment and improve aesthetics within the three ponds at the Central park subdivision. See attached. The Village has used this company previously for maintenance of native prairies and wetlands as well as monitoring services. They have extensive knowledge in designing and managing these types of plant communities and obtaining final acceptance.

A three year program will be required to establish the native prairie to acceptable standards. It is estimated the total three year cost is \$31,000. The first year contract from CBBEL is for \$18,950. Staff recommends award of the contract for the Remediation of Detention Basins and Native Vegetation at the Central Park subdivision to CBBEL in the amount of \$18,950 and to direct staff not to issue a real estate property transfer tax stamp for the three properties Pasquinelli owns until the Village has been totally reimbursed for expenses related to this work and for any outstanding invoices owed by Pasquinelli for this subdivision. The three properties are 354 Woodhill Drive (Pin 02-19-421-009), Lot 8 (Pin 02-19-207-001, and Lot 4 (Pin 02-19-420-002).

As requested, we propose to repair degraded basin slopes, enhance native vegetation establishment, and improve aesthetics within the three ponds at the Central Park subdivision in Carol Stream. Proposed remedial tasks were prepared following our May 29, 2009 field visit accompanied by a representative from Emerald Site Services, LLC (Emerald), our affiliate company that is experienced in earthwork, native landscape repairs, and installation.

This proposal covers summer/fall 2010 management and monitoring of natural areas within the identified basins. The majority of the remedial activities, proposed for 2010, will be completed by Emerald. Christopher B. Burke Engineering, Ltd. (CBBEL) will coordinate the work and observe the remedial activities during 2010. Following are our Scope of Services and Fee Estimate.

SCOPE OF SERVICES

Completion of the following tasks is understood to be the responsibility of CBBEL and Emerald.

<u>Task 1 – Completion of Remedial Activities</u>: This task includes weed control, removal and disposal of planting pods/posts, erosion repair, supplemental grass seed installation, and observation/monitoring visits within the Lot 1, 4, and 8 basins to be completed during 2010.

Task 1A - Spot-mowing of weed patches and follow-up broadleaf herbiciding will be completed in the Lot 1 and Lot 4 basins; blanket herbiciding of broadleaf weeds and follow-up will be completed in the Lot 8 basin.

Task 1B – This task includes removal of planting pods/posts from the Lot 1 & 8 basins, and removal of trash and vegetative debris from all three basins.

Task 1C – This task includes the installation of native grass seed in sparsely vegetated areas within the three basins in June or November 2010, using a native warm season grass drill where accessible and/or hand seeding/raking methods.

Task 1D – Erosion Repairs. This task includes the completion of erosion repairs as follows: sump pump discharge areas, muskrat burrow areas, and swale/surface runoff erosion areas within the Lot 1 & 4 basins; and eroding shoreline areas of the Lot 8 basin.

<u>Task 2 – Monitoring & Maintenance:</u> CBBEL staff will complete periodic site observation/monitoring visits and weed control maintenance during 2010. We will observe remedial work performed by Emerald during 2010, and monitor the condition of the basins during three growing season site visits per year. Following site visits, e-mail correspondence will be provided regarding progress updates, maintenance issues, etc. Weed control management will be completed by licensed applicators having native botanical knowledge and experience, using herbicides according to label rate and application directions. This task includes preparation of a year-end letter report describing completed activities, the overall condition of the basins, and any additional maintenance concerns or recommendations.

<u>Task 3 – Additional Services and Meetings</u>: We have budgeted for 3 meetings. Please note that any additional requested services and meetings not outlined in this proposal will be charged on a time and materials basis.

Public Works is in the process of developing a street sign database that can be used with the street sign GIS map. While preparing this database, it was noted that some stop sign locations were not in the Code of Ordinances. Most of these signs are at locations where local streets intersect with collector roads or arterials. Therefore no intersection analysis is required, and the following should be added to Chapter 8, Traffic Code; Article 5, Traffic Schedules; Schedule II, Stop Intersections Designated;

One final intersection also has a stop sign posted by the developer at Williamstown Drive and Longmeadow Drive, but this intersection is two local streets and will be addressed by a separate memo concerning "Yield Signs". Yield and uncontrolled intersections require a more in-depth sight distance analysis. They will be evaluated on a case by case basis for the 15 intersections where yield signs were posted by developers and not previously added to the Code of Ordinances.

AN ORDINANCE RESERVING VOLUME CAP IN CONNECTION WITH PRIVATE ACTIVITY BOND ISSUES, AND RELATED MATTERS.

Whereas, the Village of Carol Stream, DuPage County, Illinois (the "Municipality"), is a municipality and a home rule unit of government under Section 6 of Article VII of the 1970 Constitution of the State of Illinois; and Whereas, Section 146 of the Internal Revenue Code of 1986, as amended (the "Code"), provides that the Municipality has volume cap allocable to private activity bonds equal to \$90.00 per resident of the Municipality in each calendar year, which private activity bond volume cap may be reserved and allocated to certain tax-exempt private activity bonds; and

WHEREAS, the Illinois Private Activity Bond Allocation Act, 30 *Illinois Compiled Statutes 2008*, 345/1 *et seq.*, as supplemented and amended (the "Act"), provides that a home rule unit of government may transfer its allocation of private activity bond volume cap to any other home rule unit of government, the State of Illinois or any agency thereof or any non-home rule unit of government; and

WHEREAS, it is now deemed necessary and desirable by the Municipality to reserve all of its private activity bond volume cap allocation for calendar year 2010 to be applied toward the issuance of private activity bonds (the "Bonds"), as provided in this Ordinance, or to be transferred, as permitted by this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF CAROL STREAM, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1. That, pursuant to Section 146 of the Code and the Act, the entire private activity bond volume cap of the Municipality for calendar year 2010 is hereby reserved by the Municipality, which shall issue the Bonds using such private activity bond volume cap, or shall use or transfer such private activity bond volume cap, without any further action required on the part of the Municipality, and the adoption of this Ordinance shall be deemed to be an allocation of such private activity bond volume cap to the issuance of the Bonds or such other bonds; *provided*, that any such transfer shall be evidenced by a written instrument executed by the Mayor or any other proper officer or employee of the Municipality.

SECTION 2. That the Municipality shall maintain a written record of this Ordinance in its records during the term that the Bonds or any other such bonds to which such private activity bond volume cap is allocated remain outstanding.

SECTION 3. That the Mayor, the Village Clerk and all other proper officers, officials, agents and employees of the Municipality are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents and certificates as may be necessary to further the purposes and intent of this Ordinance.

SECTION 4. That the provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared to be invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.

SECTION 5. That all ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded; and that this Ordinance shall be in full force and effect upon its adoption and approval.

Volume Cap Reservation Ordinance

The Village has been approached by a company in town to possibly issue Industrial Revenue Bonds to finance a building expansion along with the purchase of additional equipment. At this point we do not know the name of the company (we were approached by their bank.) In order to do so, the Village will need to reserve its cap (\$3,600,360) rather than it automatically being turned over to the State. There is no cost to the Village to do this and we would have the cap available to use or to sell. This Ordinance, once approved, will need to be filed with the Governor's Office. Recognizing that there are some Board members who may not be familiar with Industrial Bonds, I have attached a brief description that is included in the "2006 Illinois Municipal Handbook."

Revenue Bonds

A revenue bond may be defined as an obligation of the municipality payable from revenues or earnings derived from the operation of the facility which has usually been constructed or acquired with the proceeds of such bonds. In Illinois, such borrowing, evidenced by the issuance of revenue bonds, does not create a debt of the municipality within constitutional or statutory limitations, Hairgrove v. City of Jacksonville, 366 Ill. 163 (1937) and therefore, such bonds are not subject to the 8.625% statutory debt-incurring limit.

Article 11 of the Municipal Code lists approximately 25 different purposes for which revenue bonds may be issued by non-home rule municipalities. In some cases, even such bonds require public notice and permit the voters, by petition, to require a back door referendum.

A municipality may usually sell revenue bonds in any amount which the market will bear. Investors, however, will not purchase such bonds unless the financial feasibility of the project to be funded allows for complete payment of the indebtedness plus interest. In order to interest investors in such bonds, net earnings of the project must substantially exceed principal and interest requirements. Sometimes in order to reduce the interest rate paid and to make the bonds more marketable, some form of regular municipal revenue such as sales tax receipts can be pledged if the cash flow from the main revenue source is insufficient to pay off the bonds. These are sometimes called "double-barreled bonds."

Industrial Revenue Bonds

Municipalities may also issue industrial revenue bonds (IRBs). These bonds bear the name of the municipality, but are payable solely by the companies or other entities that received the proceeds of the bonds as loans. These bonds typically have been used when a company wishes to build a plant in a municipality and asks the assistance of the community in financing the project. The purchasers of such bonds generally receive an exemption from federal income taxes on the interest they receive, making it possible for the municipality to issue the bonds to assist the company at reduced interest rates. The company, in turn, is able to repay the bonds at rates lower than those generally available to it from private financing sources.

Issuance of Bonds or Notes

The issuance of municipal bonds and notes is subject to a great many federal statutes and regulations. When issuing such securities, a municipality should seek the advice of a specialized law firm, often referred to as "bond counsel," who will review all documents and present an opinion to the bond purchasers that the bonds are valid and that the interest paid on the bonds by

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT FOR THE PURCHASE OF ELECTRIC UTILITY SERVICE FOR STREET LIGHTS

WHEREAS, the Village's current electric utility supplier for street lights is Commonwealth Edison (ComEd); and

WHEREAS, current electric utility rates for municipal street lights are fixed annually based upon market conditions; and

WHEREAS, effective May 2010, ComEd will begin charging electric utility rates for municipal street lights based on a floating rate that will vary by hour; and

WHEREAS, the floating rate for electricity that varies by hour has been shown to historically be higher than the fixed rate for electricity for municipal street lights; and

WHEREAS, the Village of Carol Stream wishes to receive favorable, competitive market rates for electricity by evaluating Auction rates and other bids it receives; and

WHEREAS, in order to receive the most favorable market rates for electricity, the Village must be able to award a contract for the purchase of electricity within 24-hours of receipt of bid rates; and

WHEREAS, the Mayor an Board of Trustees of the Village of Carol Stream have determined that it is expedient and in the best interest of the Village to authorize the Mayor to execute an agreement for the purchase of electric utility service.

NOW, THEREFORE, IT BE IT RESOLVED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF CAROL STREAM, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: That the Mayor is hereby authorized to execute and the Clerk to attest to a contract for the purchase of electricity for municipal street lights for Village

government purposes with the lowest cost supplier as approved by the Village Attorney.

SECTION 2: That all resolutions or parts thereof, in conflict with the provisions of this Resolution are, to the extent of such conflict, expressly repealed.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval by law.

Electric Supply Auction - Street Lights

On December 16, 1997, the State of Illinois implemented a plan to deregulate Commonwealth Edison. Under this plan, ComEd no longer generates electricity for its customers but continues to provide power through its distribution system. Alternatively, power can be purchased through any of the 23 ICC-approved power suppliers.

On July 21, 2008 you approved Resolution No. 2356 authorizing Mayor Saverino to execute an agreement for the purchase of electric utility service for our major electricity uses (water utility pumping) based on the low bid received by the Northern Illinois Municipal Electric Cooperative (NIMEC). The agreement was awarded to Exelon for a 3-year period beginning on June 2009.

We have worked with NIMEC since 2006 to purchase power for our water pumping operations. We have had a favorable relationship with NIMEC, as we have enjoyed substantial savings by purchasing power through NIMEC.

Street lighting, however, has remained with ComEd since 2007, as ComEd had a pricing advantage (except for accounts over 400 KW). That advantage will end in May 2010, when our larger street lighting accounts will no longer be able to purchase power from ComEd under a fixed rate. ComEd will only offer a floating rate after May.

If no changes are made, our largest street lighting accounts will move to this floating rate. Over the last 2 years, this floating rate has averaged 15% higher than our current fixed rate.

NIMEC has been bidding out this street light load with its suppliers. They are currently able to offer a fixed rate, which is comparable to our current rate. The fixed rate would largely be budget neutral, and would avoid the 15% increase. Currently, 1 year rates and 3 year rates are nearly identical. We would have the option to lock in rates for a multi-year duration, if we so elect.

Because of the way the bidding process works, you will need to grant authority to the Mayor or Village Manager to sign a contract with the lowest cost electricity provider within hours of the bids being received by NIMEC. Attached for your consideration is a resolution directing the Mayor of Village Manager to engage the services of NIMEC and provide Village Boardl authorization to allow the Mayor or Village Manager to execute a contract with the successful energy supplier upon receipt of the bids by NIMEC. The bid group will be comprised of the three largest energy suppliers in northern Illinois: Constellation New Energy, MidAmerican Energy, and Exelon.

Attached is a memo from our consultant David Hoover from NIMEC, describing a new opportunity to bid our electric utility service for street lights, which would lock our rates for a 1, 2 or 3 year period beginning June 2009. Locking into a favorable multi-year rate after our current agreement expires with Exelon would allow staff to budget electricity expenses with more certainty and potentially avoid future market rate increases. We would also not have to bid electricity every year if we choose or make the transition to a new carrier every year. The downside is that if rates decline in the next 3 years we would not be able to avail ourselves of the lower rate. If we believe that commodity prices for oil, natural gas or coal will decline over the next 3-years then we should not choose a multi-year rate option. We will know the proposed NIMEC Co-op rate in early May.

Because this process requires the Village to make a quick decision we would not be able to act quickly enough to secure a favorable electrical supply rate if we wait until the next regularly scheduled Board meeting. Staff recommends that the Village Board approve the attached resolution authorizing the Mayor or Village Manager to enter into a single or multi-year agreement with the lowest cost electric utility supplier subject to final contract review and approval by the Village Attorney. I am available should you have any questions regarding this process.

STREET LIGHT RATE CHANGE

Currently, Commonwealth Edison is charging your municipality a fixed rate for your street lights. The rate is re-set annually, based upon market conditions. The current rate, which expires in May 2010, is 3.3¢ per kWh.

In May, ComEd will no longer offer a fixed rate for "Medium" accounts (above 100 kW's). Instead they will offer a floating rate that will vary by the hour. The Illinois Commerce Commission is encouraging commercial users to purchase power in the competitive marketplace by removing the ComEd fixed rate option. Any commercial user desiring a fixed rate would have to move to one of the 23 ICC approved power suppliers.

The Hourly rate for street light usage has averaged 3.8¢ per kWh over the last 12 months. Therefore, if no changes are made, <u>your municipality will face a 15% increase in street light energy costs.</u>

Two years ago, when "Large" accounts were moved to this Hourly rate, it was difficult to entice any of the power suppliers to offer a price for street lighting, as it did not fit the typical commercial load. NIMEC and RRES have been working with 3 suppliers, who are now ready to offer a fixed rate alternative to the ComEd Hourly rate.

NIMEC and RRES will be aggregating interested municipalities' loads to bid out to these 3 power suppliers. Currently, our suppliers are offering fixed rates for a 12 month or 36 month term in the 3.3¢ to 3.5¢ range. Not only are these rates lower than the current ComEd Hourly rate, but the fixed rates contribute to budget certainty.

NIMEC and RRES have been specializing in the municipal market since 2002. The combined municipal client list exceeds 120. Because of this specialty, NIMEC and RRES are the first to identify this rate change, and have been working for over 2 years on attractive alternatives.

In the event that your municipality is currently working with another consultant/broker, please have them contact NIMEC or RRES. We have a broker program that respects the current relationship, while allowing the municipality to take advantage of the NIMEC/RRES specialty.




