I.T.P. #1, LLC 485 Mission St. - Spec. Use -Ord. 2010-07-40:

At their meeting on July 12, 2010, the Combined Plan Commission/Zoning Board of Appeals recommended approval of the request for a Private Recreational Facility in accordance with staff recommendations. The Board concurred with the recommendation and adopted Ordinance 2010-07-40, AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR A PRIVATE RECREATIONAL FACILITY – 485 MISSION STREET.

NACA Logistics (USA) - 250 S. Gary-SUP - Ord, 2010-07-41:

At their meeting on July 12, 2010, the Combined Plan Commission/Zoning Board of Appeals recommended approval of the Special Use to allow for NACA Logistics cartage establishment use, and the Special Use Amendment to modify the approved locations for outdoor trailer storage, subject to the conditions in the staff report. The Board concurred with the recommendations and adopted Ordinance 2010-07-41, AN ORDINANCE GRANTING A SPECIAL USE FOR A CARTAGE ESTABLISHEMENT AND APPROVING AN AMENDMENT OT A SPECIAL USE FOR TRAILER STORAGE – (250 S. GARY AVENUE).

REGULAR MEETING:

G-2: Cottony Maple Scale:

A report and recommendation on the Cottony Maple Scale that is occurring in the Village.

Trustee McCarthy said that in reviewing the problem and some of the procedures that have been done to remedy it, he is not convinced that lady bugs will do the job.

Mr. Breinig said that the only community in the area that is using lady bugs is Hanover Park. Carol Stream used to participate in that program, but in reviewing the recommendations, it would take approximately 1500 lady bugs per home and that is just too big to undertake. He suggested that introducing non-native insects could be harmful, in those amounts, to the other natural flora and fauna. Mr. Breinig reported that the production of the cottony Maple Scale is a three year process for the tree. Trustee Fenner said that she participated in the earlier programs to put lady bugs on the trees in the original part of Carol Stream and asked where all of them went. Mr. Breinig explained that the lady bugs that are purchase are not native to Illinois and they either are eaten by predators or they die off once the cold weather starts. He noted that at this stage of maple tree growth, the insects start leaving what is called "honey dew" on any and all surfaces they come in contact with and that is the problem residents are facing on their cars, clothes and sidewalks as well.

Trustee Schwarze said that this sticky residue that clings to surfaces but is easily washed away with soap and water.

Trustee Weiss said that the most logical thing to do is to educate the public about what is happening and how it can be addressed. It is nature at work and we have to live with it.

Trustee Gieser commented that 1500 lady bugs per tree is too much and there really is any way to tell if we get the good lady bugs and not the evil Asian beetles.

Trustee Manzzullo commented to the residents that came to the last meeting, the report is that it would cost \$26,000 to treat all the maple trees in the Village and there is no way that that much could be found in the budget.

Trustee McCarthy moved and Trustee Manzzullo made the second to receive the report. The motion passed by unanimous vote.

REPORT OF OFFICERS:

Trustee Manzzullo asked everyone to pray for our troops and their families.

Trustee McCarthy wished his son Colin a Happy 14th Birthday.

Trustee Fenner asked everyone to be careful out there.

Mayor Saverino thanked the Village of Glendale Heights for the loan of the golf carts for the Parade, it was very generous and greatly appreciated. He thanked the Staff for all of there help at Town Center events and he thanked the Fire Department and the Citizen Police Academy volunteers that helped with the clean up. Mayor Saverino thanked everyone that donated a toy to Toys for Tots. He noted that Carol Stream did not get any monetary amount from the ComEd energy challenge, but we did get a participation plaque for our efforts in reducing our carbon emissions and carbon footprint and he thanked Chris Oakley, Assistant to the Village Manager for stepping in for him. Permit Fee Waiver for Flood Damage Restoration Work

PURPOSE

The purpose of this memorandum is to obtain direction from the Village Board regarding building permit fees for repair work associated with the flood event of July 23 and 24, 2010.

BACKGROUND

Following the flood event in September of 2008, the Village Board directed staff to prepare and implement a procedure for waiving building permit fees for property damage restoration work brought about by the flood event. The permit fee waiver was considered to be a temporary administrative change to Chapter 6, Article 13 *Permit and Inspection Fees*, of the Carol Stream Code of Ordinances. The permit fee waiver was effective for one year, and staff made reasonable efforts to determine that the permit work was related to flood damage. Permit fees for a total of seven building permits were waived in accordance with the Board's direction.

In view of the flood event that occurred on July 23 and 24, 2010, staff is requesting direction from the Village Board as to whether the Board wishes to again institute a temporary waiver of building permit fees related to flood restoration work. If the Board is so inclined, the fee waiver could again be in place for a period of one year, which would run through July 25, 2011. As was the case in 2008, there would be no eligibility restriction based on the use of the property – residential, commercial, institutional or industrial – however, our damage assessment indicates that property damage was likely limited to residential properties. Staff would make every effort to streamline the review and approval of permit applications flood restoration work. Typical inspection fees would also be waived; however, while we do not anticipate a problem, staff suggests that we reserve the right to charge re-inspection fees if there is a strong indication that the work is not being performed responsibly.

RECOMMENDATION

If the Village Board concurs with the staff recommendation, they should approve by motion the proposed temporary administrative change to Article 13 of Chapter 6 of the Carol Stream Code of Ordinances, to waive permit fees for flood restoration work, to be effective until July 25, 2011.

Village of Carol Stream FLOOD DAMAGE REPAIR PERMIT INFORMATION

<u>Purpose and Intent</u> – This informational guide is intended to make property owners, tenants and contractors aware of the Village of Carol Stream's building permit requirements with respect to the repair of damage caused by the recent flood event.

Waiver of Fees – As directed by the Carol Stream Village Board, permit and inspection fees for the repair of flood damage will be waived. This waiver applies only to properties damaged during the flood event of July 23 and 24, 2010. Please be advised that this is a temporary administrative change to the Carol Stream Building Permit and Inspection Fee Schedule, and this waiver will expire July 25, 2011.

Work Requiring a Permit

- 1. Replacement of furnace or water heater.
- 2. Replacement of electrical wiring or service panel.
- 3. Structural repair.

Work Not Requiring a Permit

- 1. Drywall and insulation replacement.
- 2. Carpet replacement.
- 3. Siding replacement.
- 4. Replacement of electrical switches, receptacles or circuit breakers, in kind or similar.
- 5. Replacement of light fixtures, in kind or similar.
- 6. Cleaning, painting, and other such cosmetic work.
- 7. Other non-structural work.

As all of you are aware, Carol Stream and the rest of the country and world are experiencing the worst economic depression of our lifetime. We just completed a series of budget workshops where we prioritized Village services and had to make some hard decisions that resulted in some reductions in services and in our labor force. Several events were also cancelled this year at the Town Center as part of these cost saving efforts. Twelve long-term Village employees recently left as part of the voluntary separation program we approved on January 4, 2010 to reduce labor costs. The last group of these employees left on June 30. We considered many cost cutting/saving options during the 6 budget workshops held last year and feel we made some good, albeit hard decisions that not only cut costs without having to implement any major new taxes but allowed us to maintain service levels and continue to provide events to our residents who are also feeling the pain of the current and lasting economic depression.

During our goal setting workshops held in 2007 and updated annually, we identified and listed in the Financial Plan & Budget the goals we felt were important to the community. One of these goals was to review our overall legal services model to determine the most cost effective option. We determined that, although we periodically review other professional contractual services of the Village, we have not done so with the Village Attorney which has remained with Ancel-Glink for the past 40 years. As part of this review, staff contacted 7 highly regarded, well established law firms specializing in municipal law. Staff requested that they submit to us letters of interest and qualifications for Village Attorney services. The following 6 law firms expressed an interest and submitted proposals for Village Attorney:

- Klein, Thorpe and Jenkins, Ltd.
- Raysa & Zimmermann, LLC

On June 1, 2 and 8 we along with Joe Breinig and Bob Mellor interviewed attorneys from the 6 law firms who submitted proposals. Each law firm was well qualified and each provided their own unique approach to providing Village Attorney services. After interviewing attorneys from each firm we compared Village Attorney rates for our top 2 choices:

Ancel, Glink, Diamond, Bush, DiCianni & Krafthefer, P.C. \$225/hour Klein, Thorpe and Jenkins, Ltd. \$190/hour

Legal Actions

Although a comprehensive listing of all of our litigation over the past ten years would be fairly lengthy, we have attached a listing of some of our most significant litigation matters during that period, at Tab 4.

Grievances and Litigation Involving Firm

Granat v. Maher et al., Circuit Court of Cook County, o8 L 3758. The complaint alleges, among other things not pertinent, that two partners of the firm

were involved in conducting an investigation for our client related to possible fraudulent military leaves claimed by a firefighter employed by a Fire Protection District client of the firm. Our investigation report to the District Trustees, though privileged and confidential, was made public by unknown means, and the Plaintiff, a former fire officer with the District, alleges that the report contains statements that are defamatory as to him. The complaint was dismissed by the Circuit Court for failing to state a proper claim. The matter is currently pending in the First District Appellate Court on the issue of whether the trial court correctly dismissed the complaint.

Village of Mount Prospect and Lance Malina, Circuit Court of Cook County, Chancery Division, Case No. 03 CH 18409. In 2003, the Village filed a foreclosure action to enforce its recorded liens for maintenance work performed on certain property, which action was later amended to include two nuisance counts. The Defendant filed a counterclaim for slander of title against the Village, the Village's Deputy Finance Director, and an attorney for Klein, Thorpe & Jenkins, Ltd., who executed one of the notices of lien as the Village's attorney. In 2007, the case was dismissed as the property owner agreed to fence and maintain the property.

LITIGATION PRACTICE

KTJ provides its clients with a wide range of litigation services.

Of course, the primary aim of litigation defense is to remove the municipal client from the litigation with as little cost as possible. But, in certain cases, settlement or pre-trial disposing of a case is impossible. KTJ has a stellar history in defense as well as prosecutions.

A few of our recent successes at trial illustrate our ability to successfully try a wide variety of municipal cases:

- KTJ successfully defended a multi-year litigation at trial in the Northern District of Illinois. Orlowski v. Eriksen (N.D. Ill. 2009). The plaintiff alleged excessive force, false arrest, and malicious prosecution against the Defendant police officer. The Plaintiff sought hundreds of thousands of dollars in lost wages and physical and emotional pain and suffering. After success on obtaining a directed verdict on the malicious prosecution count, the Defense successfully obtained a jury verdict of zero dollars against the Defendant Officers, including no Section 1988 fees paid to Plaintiff's counsel.
- KTJ obtained a directed verdict in favor of Orland Park and the Defendant police officer on all counts in an action arising from an automobile accident between the Plaintiffs and an Orland Park Police Department squad car. Plaintiffs were claiming severe and permanent injuries as a result of the collision. Stehlik v. Orland Park (Cir. Ct. Cook Cty. 2009). After argument on directed verdict, Judge Robert Lopez Cepero granted a directed verdict in favor of the Village and the Defendant officer on all counts, thereby taking the decision away from the jury after ten (10) days of trial, an extraordinary remedy that is not often exercised by the courts.
- KTJ obtained a judgment in favor of the Village of Burr Ridge pursuant to a public nuisance complaint arising from the discharge of raw sewage into a creek within the Village. Burr Ridge v. Missbrenner (Cir. Ct. Cook Cty. 2009). The Village requested a mandatory injunction requiring the occupant to repair the septic system or connect to the Village's sanitary sewer system. After two (2) days of trial, the Honorable Judge William O. Maki found in favor of the Village and found that the condition of the property was detrimental to the public health, safety, and welfare. The court granted the Village's request for a mandatory injunction, ordered the Village to connect the home on the property to the Village's sanitary sewer system with the costs of such connection to be borne by the defendants.
- KTJ obtained an order on behalf of Northfield requiring British Petroleum to pay a fine of \$15,000 for failure to comply the village code with respect to abandoned gas stations. Vill. of Northfield v. B.P. America, Inc. (Cir. Ct. Cook Cty. 2009).

- KTJ successfully defended the revocation of a business license for Mount Prospect on administrative review. Young Vernon v. Mt. Prospect, (Cir. Ct. Cook Cty. 2009). Plaintiff, an owner of a massage parlor, filed a complaint for administrative review after the Village revoked its business license. Employees of Plaintiff were arrested during a police undercover sting investigating alleged prostitution on the premises. The Village revoked Plaintiff's business license due to the unlawful conduct performed on the premises of Plaintiff's business. After a hearing on administrative review, the Circuit Court of Cook County ruled in favor of the Village's revocation of Plaintiff's business license, finding the Village had discretion, under its Village code, to revoke the Plaintiff's business license as a result of the conduct that occurred on the premises of Plaintiff's business.
- KTJ successfully defended a two-week trial on Section 1983 excessive force, unlawful arrest, and federal Rehabilitation Act claims brought by a hard-of-hearing arrestee against the Village of Wheeling and the defendant officers. Spencer v. Dawson (N.D. Ill. 2007). The Jury found for all defendants on all counts, specifically finding no violation of federal law in the defendant officers' decision not to bring a sign-language interpreter on an emergency call that came over the TTY.

Notwithstanding KTJ's expertise at trying cases at both the state and federal levels, KTJ has also had tremendous success in important motions to dismiss, summary judgments, TROs, hearings, and appeals. App. 3d 715 (2d Dist. 2006) [holding that Village Commission could not unilaterally stay the Village Trustees' decision to demolish a municipal "historically significant site"]; Village of Western Springs v. First United Methodist Church, 211 Ill.2d 617 (1st Dist. 2004) [place of worship required to comply with fire, building and zoning codes in order to operate a homeless shelter]; Chavada v. Wolak, 188 Ill.2d 394 (Ill. S.Ct. 1999) (interpreting the Illinois vacation of right-of-way statute]; Ryan v. Board of Fire and Police Commissioners, 176 Ill.2d 592 (Ill. S.Ct. 1998) Jupholding right of Village to refuse to rescind a voluntary resignation by a police officer]; Cohen v. City of Des Plaines, 8 F.3d 484 (7th Cir. 1993) [treating constitutional

issues of due process and the Establishment Clause of the First Amendment within the context of municipal powers to control property use]; Launius v. Bd. of Police & Fire Commissioners of Des Plaines, 151 Ill. 2d 419 (1992) [nationally publicized police officer dismissal case]; Maganuco v. Leyden Community High Sch. Dist. No. 212, 939 F.2d 440 (1988) [landmark case interpreting a governmental body's right to restrict the use of paid sick leave and pregnancy time off through a collective bargaining agreement]; Ryan v. Village of Oak Lawn, 176 Ill. 2d 592, 690 N.E.2d 1387 (1998) [upholding the enforceability of the resignation of a police officer] and Bd. of Trustees v. Krizek, 113 Ill.App.3d (1983) [landmark case involving a dismissal of a community college faculty member.]




