#### Fee waiver - Library Remodeling Project:

The Board approved the waiver of fees for Building Permits for the Carol Stream Public Library's remodeling plan. The waiver does not extend to reviews and other activities where out-of-pocket costs are incurred.

#### Raffle License - fee waiver - Spring Trail School PTO:

The Board approved the waiver of fee and Manager's Fidelity Bond for a Raffle License for Spring Trail School's PTO.

#### Sound Amplification Permit – Outreach Community Center:

The Board approved a waiver of fees for a Sound Amplification Permit for the Outreach Community Center for an outdoor community event, Fiesta Latina, on September 25, 2009.

#### Carol Stream Census 2010 - Outreach Plan:

The Board accepted the proposed Census 2010 Outreach Plan. Mayor Saverino and the Trustees all stated how important this census will be to everyone in the Village.

#### Regular Bills, Addendum Warrant of Bills, Treasurer's Report:

The Board approved the payment of the Regular Bills in the amount of \$552,196.49.

#### **REGULAR MEETING:**

#### Proposed Energy Efficiency Contract for Automating the Sludge Aeration Process:

This award to Design/Build Contract to CH2M Hill/OMI to design and install the computerized aeration control system and is to be funded by a DEO-Conservation Block Grant in the amount of \$152,000.

Trustee McCarthy asked what the life-span of this computerized system will be and Public Works Director Al Turner said that it should be 20+ years. Trustee McCarthy said that when the grant was received the Board wanted it used wherever the Village could get the best bang for the buck and to be saving 400,000 kilowatt hours a year which equates to a \$30,000 per year savings is a great use for the grant money.

Mr. Breinig said that in an energy audit that was done that specified that this was the most cost effective project. He noted that Dawn Smith, representing OMI is present to answer any specific questions from the Board.

Trustee Manzzullo said that he was prepared to make the same comments that Trustee McCarthy has made and he agrees that it is a great use of grant money.

Mayor Saverino said that he is very happy about the 400,000 kilowatt hours.

Trustee McCarthy moved and Trustee Manzzullo made the second to award the Design/Build Contract to CH2M Hill/OMI for automating the Sludge Aeration Process. The results of the roll call vote were:

#### **REPORT OF OFFICERS:**

Trustee Manzzullo thanked Dirk Enger for his report from the DuPage County Board. He reminded everyone of the Oktoberfest at the Town Center 9/25 through 9/27 and the Town Meeting on the Shape of Carol Stream on September 30<sup>th</sup> here at the Municipal Center and reminded everyone to pray for our troops.

Trustee McCarthy congratulated all of the Community Pride winners and said that fall is approaching and now is the time for home owners to check heating systems, water and pick up and put away yard items before it gets too cold and he asked that residents should see if any elderly neighbors can use help for these matters.

Trustee Fenner said that she hopes all will take advantage of the beautiful weather and to watch out for kids darting out into the street, especially in the shorter daylight hours.

Trustee Gieser noted that the Arts Alliance has recognized the Village Art's programs with an honorable mention. He thanked Frank Slepicka for his participation in the Historical Recollect ion series. Trustee Gieser said that there will be another Historical Roundtable Discussion with the Fire District. Participants will be Joe Bird, Mike Tuman, current Chief Kanzia, Bonnie Miller, a long time employee, and several members from the Volunteer days. Trustee Gieser also congratulated the Community Pride winners. Mayor Saverino thanked Trustee Gieser for the great job he is doing with the Historical Recollection Series.

Trustee Schwarze also thanked Mr. Enger for the update on the County Board, if a resident wants to contact his there is a link on <a href="www.dupageco.org">www.dupageco.org</a>. Trustee Schwarze thanked Mr. Slepicka for his recollection and he noted that the Fire District Open House and the Water Treatment Plant Open House will be on 10/10 from 11a.m. to 3 p.m. Trustee Schwarze said that the 2010 Census Outreach Plan is very important to the residents of the Village and he urged everyone to respond to the questionnaire when it comes in the mail. He ended his remarks by reminding everyone to Shop Carol Stream.

Trustee Weiss displayed the post card sent to residents reminding all about the Shape of Carol Stream Town Meeting on September 30<sup>th</sup> and noted that it will be live and residents may call in with questions or e-mail them.

Village Manager Breinig noted that there will be a meeting on September 28<sup>th</sup> at 7:00 p.m. at Benjamin School in regard to Southwest water project and the time line showing the scope of the project. He said that the remaining steps in the project and where that timeline is at present. Mr. Breinig said that the Village is in the early stages of creating the e-newsletter, and there is place on the web site for people to subscribe by sending their e-mail address. There will further outreach at other events to get as many residents as possible to sign up for the e-mail newsletter. There will still be hard copies available at the Village Hall, the Library, the senior complexes and the Park District. Mr. Breinig said that Fire Chief Mike Kanzia will be retiring and said that it has been his pleasure to work with Mike as Chief and for the last several years.

Mayor Saverino said that he has been busy with community activities starting with the 9-11 ceremony at the Town Center was fantastic and very memorable. Glenbard North also saluted the Police and Fire Departments on 9-11 along with those of other communities. Carol Stream School celebrated their 50<sup>th</sup> anniversary and Trustee Gieser attended and brought his 5<sup>th</sup> grade picture. Lutheran Church of the Master celebrated their 40<sup>th</sup> anniversary, Belmont Village honored all of their war heroes that are in residence. They had pictures taken in each facility and then hung the current photos and photos of them in uniform and hung them in an area of the building. Mayor Saverino said that this is the anniversary of the death of Lenny Gulczynski in Iraq and his family had a ceremony that started at Bartlett High School, went to Ascension cemetery for full military honors which included the men from the unit he served with. 

WHEREAS, the 2009 Fire Prevention Week theme, 'Stay Fire Smart --- Don't Get Burned!' effectively serves to remind us all of the simple actions we can take to stay safer from fire during Fire Prevention Week and year-round.

#### DECLARING OCTOBER 2009 BREAST CANCER AWARENESS MONTH IN CAROL STREAM

WHEREAS, approximately 1 in 8 women will develop breast cancer in their lifetime; and

WHEREAS, breast cancer is the most commonly diagnosed cancer and the second leading cause of cancer deaths among women in the United States; and

WHEREAS, it is estimated that 7,610 new female breast cancer cases in Illinois will occur in 2009, and it is also estimated that approximately 1,770 women will die of breast cancer in Illinois in 2009; and

WHEREAS, nationally, approximately 192,370 new cases of invasive breast cancer are expected to be diagnosed among women in 2009, and it is also estimated that nationally 40,170 women will die of breast cancer in 2009; and

WHEREAS, every woman is at risk for breast cancer even if she has no family history of the disease, but women over the age of 40 are at the greatest risk for being diagnosed with breast cancer; and

WHEREAS, the overall 5-year survival rate for women diagnosed with breast cancer is 86% and the overall 10-year survival rate is 76%. When breast cancer is diagnosed early (Stage I) the 5-year survival rate for women is 100%; and

WHEREAS, a mammogram is the single most effective method of detecting breast changes long before physical symptoms that may be cancer can be seen or felt; and

WHEREAS, October is designated as *National Breast Cancer Awareness Month* and local hospitals such as Central DuPage in Winfield and its convenient care facilities in Bartlett, Bloomingdale, Naperville, Wheaton, St. Charles, Glen Oaks Hospital in Glendale Heights and for income-qualified at the DuPage County Health Department in Wheaton will all be offering low cost breast cancer screenings throughout the month of October; and

WHEREAS, the pink ribbon is the internationally recognized symbol of breast cancer awareness; and

WHEREAS, community organizations, churches, synagogues and other places of worship, and work sites can play a special role in educating their members or employees about breast cancer;

# NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR THE VILLAGE OF CAROL STREAM, DUPAGE COUNTY, ILLINOIS

I. A public hearing to approve a proposed property tax levy increase for the Village of Carol Stream (including the Carol Stream Public Library) for 2009 will be held on November 2, 2009 at 8:00 p.m. at the Carol Stream Village Hall, 500 North Gary Avenue, Carol Stream, Illinois.

II. The corporate and special purpose property taxes extended or abated for 2008 were \$3,404,818.30.

The proposed corporate and special purpose taxes to be levied for 2009 are \$3,456,555.00. This represents a 1.015% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2008 were \$0.00.

The estimated property taxes to be levied for debt service and public building commission leases for 2009 are \$0.00. This represents a 0.00% increase over the previous year.

IV. The total property taxes extended or abated for 2008 were \$3,404,818.30.

Opening of Bids for the Sale of the Property at the Southwest

Corner of the Intersection of Elk Trail and Bluff Street

#### **PURPOSE**

The purpose of this memorandum is to provide the Village Board with information regarding the opening of bids for the referenced property, to take place at the regular meeting of the Village Board on October 5, 2009.

#### **DISCUSSION**

The property at the southwest corner of the intersection of Elk Trail and Bluff Street was acquired by the Village from First Bank of the Americas in 2007. First Bank acquired the property in 2003 due to the bankruptcy of the previous owner. Prior to its acquisition by First Bank, the property was the subject of repeated code enforcement action by the Village for property maintenance violations, and after going many years without maintenance or development, a wetlands had established itself on the property, rendering it much less feasible for commercial development. First Bank was unable to sell the property to a developer, and so they donated it to the Village for possible enhancement as a nature area.

F&F Realty acquired the Lakehaven Apartments property on Bluff Street in 2008, and during the course of their acquisition they approached Community Development with the idea of using the vacant corner parcel for a monument sign. In order to do so, F&F would need to acquire the parcel, which is adjacent to Lakehaven Apartments. Several months ago, F&F informed Village staff that they wished to proceed with the property acquisition.

The Village Attorney has identified the procedure by which the Village may sell property by bid in accordance with Illinois statutes, and this procedure has been followed. Attached is a copy of the bid notice, which has appeared in the

Daily Herald once a week for three consecutive weeks. Bids will be accepted at the Community Development Department up until 5:00 pm on October 5, 2009, and will be opened and read aloud during the Village Board meeting that evening. With the determination of an acceptable bid, and concurrence from the Village Board, staff would then prepare an ordinance to convey the parcel for approval at the next Village Board meeting on October 19, 2009.

#### RECOMMENDATION

If a satisfactory bid is received, staff would request concurrence from the Village Board to prepare an ordinance to convey the parcel to the selected bidder.

Smoking Shelter - Flip Flops Tiki Bar and Grill

#### **PURPOSE**

The purpose of this memorandum is to summarize a request from Flip Flops Tiki Bar and Grill to allow a tent, canopy or membrane structure to be used as a smoking shelter.

#### BACKGROUND

The Smoke-Free Illinois Act, which became effective on January 1, 2008, prohibits smoking in all indoor workplaces, including bars, taverns, private clubs and restaurants. Smoking is also prohibited within 15 feet of all building entrances and exits, windows that open, and ventilation intakes. Some businesses in Carol Stream have sought to install smoking shelters to provide an outdoor location for smokers out of the weather elements. Such structures are subject to local zoning and building code regulations.

From a zoning standpoint, some Illinois communities have prohibited smoking shelters outright. In these communities, businesses are not able to erect stand alone structures to accommodate patrons who smoke. Other communities, including Carol Stream, have developed specific zoning regulations that establish the allowable size, location and aesthetic aspects related to smoking shelters. Carol Stream adopted zoning regulations for smoking shelters in the fall of 2008.

From a building standpoint, smoking shelters are subject to the adopted building codes of the community. In Carol Stream, the 2006 International Code Council series of codes, with relatively few local amendments, are in effect. There are several different types of structures that could be used as a smoking shelter that would comply with the applicable Building Codes. However, one category of structures that is not approved for use as a smoking shelter by the 2006 International Fire Code (IFC) includes tents, canopies and membrane structures.

The current Building Code regulations that apply to smoking shelters focus on three principal factors, outlined below.

- 1. **Temporary versus permanent** Section 3103.1 of the International Building Code provides a distinction between temporary versus permanent structures, and also clarifies the Codes that apply to these two categories of structures. A structure is considered a temporary structure if it is erected for a period of less than 180 days. Further, Section 3103.1 of the IBC states that, "tents and other membrane structures erected for a period of less than 180 days shall comply with the International Fire Code."
- 2. **Structure size** Section 3103.1.1 states that "temporary structures in excess of 120 square feet shall not be erected without obtaining a permit from the Building Official." For such structures, the applicant must submit a building permit application complete with construction documents, including a site plan, information delineating the means of egress, and occupant load. If the structure is less than 120 square feet in area, the Village would not issue a building permit.
- 3. **Structure type –** Section 2404.6 of the IFC states that, "Smoking shall not be permitted in tents, canopies or membrane structures."

#### REQUEST

Bob Sabalaskey, owner of Flip Flops Tiki Bar and Grill, is requesting that the Village allow the continued use of a tent or canopy structure as a smoking shelter. Flip Flops has used a tent or canopy structure as a smoking shelter over the past two winters. The Village did not disallow use of the structure during the winter of 2007/08, as the Illinois Smoke Free Act had just become effective on January 1, 2008. The Village also did not disallow the use of the structure during the winter of 2008/09, as Flip Flops had filed an application for formal zoning approval which was under review. Village staff has advised Flip Flops that the tent or canopy smoking shelter structure used over the past two years cannot be approved for use this coming winter, since the 2006 IFC, adopted by the Village in May, 2009, prohibits smoking in such structures.

Section 2404.6 of the International Fire Code, in its entirety, reads as follows:

**2404.6 Smoking.** Smoking shall not be permitted in tents, canopies or membrane structures. Approved "No Smoking" signs shall be conspicuously posted in accordance with Section 310.

To allow Flip Flops to continue using the type of smoking shelter they have used each of the past two winters, the Village Board could adopt the local amendment to the International Fire Code, set forth below, which would remove the prohibition against smoking in tent or canopy structures. (Text to be added is shown in <u>underline</u> format; text to be deleted is shown in <u>strikethrough</u> format.)

**2404.6 Smoking.** Smoking shall not be permitted in temporary tents, canopies or membrane structures that are less than or equal to 120 square feet in area. Smoking shall not be permitted in temporary tents, canopies or membrane structures greater than 120 square feet in area. For structures greater than 120 square feet in area, aApproved "No Smoking" signs shall be conspicuously posted in accordance with Section 310.

#### **DISCUSSION**

If approved, the above language would become a local amendment to the adopted 2006 IFC, and would allow a tent, canopy or membrane structure up to 120 square feet in area to be used as a temporary smoking shelter. The 120 square foot area threshold is significant because temporary structures less than or equal to 120 square feet are exempt from building permit review or issuance.

The Carol Stream Fire Protection District has reviewed the proposed local amendment to the 2006 IFC. A copy of the Fire District's comments is attached. The Fire District does not support the amendment to allow smoking in tent or canopy structures.

As a point of information, it should be noted that if the Village Board approves the local amendment, Flip Flops' smoking shelter would require review and approval through the Gary Avenue Corridor Review process. Flip Flops submitted an application for Gary Avenue Corridor Review for the structure in January 2009, but that review has been on hold while the Building Code (International Fire Code) requirements applicable to the structure have been under discussion.

#### RECOMMENDATION

If the Village Board should wish to allow tents, canopies or membrane structures up to 120 square feet in area to be used as temporary (up to 180 days/year) smoking shelters, a local amendment to Section 2404.6 of the International Fire Code will be required. If the Board so directs, staff will prepare an Ordinance for adoption by the Board.

Dear Mr. Bastian:

As you know, the Fire Code is a minimum standard and states "The purpose of this code is to establish the minimum requirements consistent with nationally recognized good practice for providing a reasonable level of life safety and property protection from the hazards of fire, explosion or dangerous conditions in new and existing buildings, structures and premises and to provide safety to fire fighters and emergency responders during emergency operations." Additionally, Section 2404.6 of the IFC specifically and clearly prohibits smoking in tents canopies or membrane structures.

After careful consideration of this proposal, we believe that the Fire Code should not be amended to allow smoking in tents or fabric structures regardless of the size and the Fire District would not support such an amendment.

The Village's DUI Prosecutor Thomas Howard proposes the attached proposed increase in DUI fines. The fines have not been increased since the Village began local prosecution of DUIs in October 2004.

To: Police Chief Kevin Orr

Re: Immediate change to fine structure for DUI cases

Effective on September 7, 2009, the fine structure in Carol Stream for DUIs has changed. No change to the existing code is needed.

#### DUI

Minimum fine-1st offender rises to \$1500 from \$1000

- if the BAC is higher than .16, the minimum fine is \$2000

-2<sup>nd</sup> offender DUI fine is \$2000

#### **Reckless Driving**

For CDL 1st offenders and weak cases reduced to Reckless Driving, the minimum fine rises from \$1500 to \$1750.

If the Reckless driving case was good, but there was some compelling reason to reduce the charge, the fine rises to \$2500.

#### **Recission of Summary Suspensions**

The recission for a 1st offender rises to \$1000, from \$500.

The increases based on a volume of 500 cases per year would be as follows:

Increased DUI fines would rise by \$175,000. Increased Recission fines would rise by an amount of \$75,000.

Reckless Driving fines would generate an added \$75,000 a year.

The new fine increases should generate an additional \$325,000. Because the fine increases will initially raise concerns with the bench and bar, I would like to postpone a Home Rule tech fee of \$300 until late in 2010. No Village Board action is needed for the increases noted herein.
