REPORT OF OFFICERS:

Trustee Manzzullo wished everyone a very Happy Holidays and New Year and hopes that 2010 is a better year for everybody. Thanked Carol Stream for her recollections and thanked Trustee Gieser for the fantastic job he has done with the Recollections, saying as being a resident since 1994 he learned more about the Village through the recollection that all of the years he has been in the Village. Congratulations to Sgt. Cooper on his promotion, and the 80lb and 90lb Football players, Officer Garza for his work on Community Night Out and the award that was received. Trustee Manzzullo wished Happy Holidays to all of the service men and women serving all over the world.

Trustee Schwarze reiterated all of the congratulations given by Trustee Manzzullo to the football teams, and to Sgt. Cooper. Trustee Schwarze said that he would like to the Chief and the Village staff for supporting the public education portion of the Police Department. As Officer Garza presented the national Night out Award, it would not have happened with the support of all of the staff. He reminded that in a couple of short months the 2010 Census forms will be coming to everyone and Trustee Schwarze asked everyone to fill out the form and return it, because for everyone person that does that, the Village will receive \$14,000 over the next 10 years. He said that Jay Stream, Carol's father, a man without tremendous expertise in municipal planning did an extraordinary job in deciding to divide this town into residential, commercial and

industrial and that every citizen of the community has benefited from it for this long period of time. Mr. Diamond wished everyone a Merry Christmas and a happy New Year.

Village Clerk Beth Melody thanked Trustee Gieser for the Recollection Series saying that it was awesome, and wished all a Merry Christmas and a happy New Year.

Village Manager Joe Breinig reminded everyone of the Budget Workshop on January 11, 2010 and another workshop on January 21st. He said that digital version of the Newsletter will be on the Website this week, and said that a limited number will be given to the Library and some of the senior complexes where internet access may be limited. He asked all residents to sign up for the newsletter and the information blasts that will be sent out about every two weeks; this is available at the Village website www.carolstream.org. Mr. Breinig noted that the Board approved the snow removal contracts, and we have been able to hold the price to the same as the previous year and the amendment for the tree agreement allows reshaping the planting program to allow the Village a little longer time and reducing some of the annual costs. The staff continues to look for ways to massage the budget and make the money go a little further. He wished everyone Merry Christmas and Happy New Year to all.

Mayor Saverino said Congratulations to the new Sergeant and thanked everyone who helped with Christmas Sharing and distributing everything to the neediest of our Village. He congratulated the football teams, the Public Works Department for taking care of snow storm and the entire staff for doing the work that they do. Mayor Saverino said that in January the budget process will being to make decisions, some of them really difficult, but the staff and the Board will so what will keep Carol Stream a great place to be and to live and raise families. Special thanks to Carol Stream for her participation on the telephone. What a great way to end the Fiftieth Anniversary Year of the Village. Mayor Saverino wished every one a Merry Christmas and Happy New Year and he thanked all of the Trustees for supporting him and also thanked the Staff for their support. Happy Holidays to everyone in Carol Stream and he wished for a better 2010. The Board will adjourn to Executive Session to discuss Negotiation Matters and there will be no action. The Board will adjourn directly from this session.
