The Illinois Environmental Protection Agency has reviewed your information requesting shared coverage of an NPDES permit and have determined that storm water discharges from your municipal separate storm sewer system are appropriately covered by the attached NPDES general permit issued by the Agency to DuPage County

The Village of Carol Stream is hereby considered a Co-Permittee to DuPage County MS4.

This permit as issued covers Notice of Intent requirements, storm water management plan requirements, and monitoring, recordkeeping and reporting requirements.

Failure to meet any portion of the permit could result in civil and/or criminal penalties. The Agency is ready and willing to assist you in interpreting any of the conditions of the permit as they relate to your municipal separate storm sewer system. Per 40 CFR Section 122.33(b)(3), Co-Permittee's must comply with the requirements of 122.26. A Notice of Intent must be submitted within 180 days of the date of this letter.

Please note that you must submit a new Notice of Intent request 180 days prior to the expiration of the current ILR40 permit. The submittal is due on or before September 1, 2020.
