#### Water and Sewer Fund and other Funds (cont. from 3/6/17)

Finance Director Jon Batek continued with the Water and Sewer Fund discussion from the prior meeting on March 6, 2017. Jon Batek discussed the smaller funds including the Police Pension Fund, General TIF Fund and the North Avenue/Schmale Road TIF Fund. Details are as follows:

#### Water & Sewer Fund FY17/18 CHANGES MADE SINCE MARCH 6 BUDGET WORKSHOP

- \$4,130,000 Meter Replacement program removed from budget along with related debt financing.
  - More time is needed to more fully review the program with the Village Board and build consensus on key issues:
    - Timing / Phasing
    - Technology
    - Implementation Internal vs Consultant

Funding /Financing

• Additional workshop(s) will be scheduled in FY17/18 to continue review/discussion of options.

• Should Village Board decide to proceed, we will then amend the budget to reflect financial impact of program.

Added (\$130,000 + additional \$20,000) for "normal" meter replacements during FY17/18

\$100,000 to continue large meter replacement program.

\$30,000 + additional \$20,000 for anticipated residential meters.

Since most of these costs (\$130,000) were included in proposed borrowing, they now must be covered by current user rates/charges. This will alter the previous rate recommendation presented on March 6th.

#### RATE RECOMMENDATION

- Water Fund
  - Each penny of water rate generates approximately \$10,900 of revenue based on anticipated water sales.
  - The presented water budget falls short of covering operating and debt expenses by \$345,000 which can be neutralized with a rate increase of 32 cents.

8 cent increase anticipated from Chicago/DWC

+ 24 cents to cover remaining operating costs/debt

32 cents total water rate proposed for May 1, 2017

Will not provide any additional funds for future capital.

- Sewer Fund
  - Each penny of sewer rate generates approximately \$8,700 of revenue based on anticipated water sales (less than water because there are approx. 700 customers served by Wheaton Sanitary Dist).
  - The presented sewer budget falls short of covering operating and debt expenses by \$356,000. It would take a rate increase of about 40 cents to cover this gap.
  - In an effort to more evenly spread rate increases over a number of years, we are recommending a lesser increase of 28 cents to continue to work toward fully covering operating expenses and debt.
  - No additional funds raised for future capital projects.

What Rates would be needed to fully support the current proposed FY17/18 Water & Sewer Budget?


Water

- A rate increase of \$3.09 would be needed to cover budgeted FY17/18 water operations and capital costs.
- That would be a 45% increase over current rates.

Sewer

- A rate increase of \$0.93 would be needed to cover budgeted FY17/18 sewer operations and capital costs.
- That would be a 27% increase over current rates.


Water & Sewer Fund Community Comparison – Water

#### **Police Pension Fund**

- Funding comes from three (3) sources:
  - Officer Contributions (9.91% of Base Pay)
  - Interest Earned on Investment Portfolio
  - Actuarial Contribution Made by the Village
- \$41.5million in net assets at April 30, 2016.
  - \$2.2 million in benefit payments made.
  - Net decrease of \$84,000 for FY15/16.
- 59.4% funded as of April 30, 2016 (Under new GASB 68 rules).
- Village contribution increases by \$240,000 or 13.1% in FY17/18 over FY16/17. FY17/18 contrib. = \$2.073M.

#### **Geneva Crossing TIF**

#### **TIF Close-Out Procedures**

TIF was closed December 31, 2016 per Village Board Ordinance adopted 10/17/16.

- Current TIF Cash Balance (1/31/17) = \$760,631.
- Final distribution to taxing jurisdictions based on County formula Village retains 10% as its distribution.
- Project returning unused balances to County prior to 4/30/17.
- Any funds held in escrow will be retained in the General Fund (until ultimately released to taxing jurisdictions).

#### North Ave./Schmale Rd. TIF

- Structured differently than Geneva Crossing TIF:
  - No up front bond sale. Privately financed.
  - Non-monetized Village note of \$3.5M.
  - Secured by 100% of incremental property taxes + 50% of sales taxes for a period of 13 years. 2 year extension if total principal not paid (incremental property taxes ONLY).
- Caputo's operational September, 2014.
- Principal and Interest (P&I) payments on the note are due on June 30 and December 31 each year.
- At present, only enough funds have been generated to pay partial interest on the note. Anticipated to catch-up and begin paying toward note principal during FY17/18.

#### Village Board concurred to:

Raise water rate to 32 cents and raise sewer rate to 40 cents. Staff to bring Ordinance to the Village Board at their April 3, 2017 meeting. Trustee McCarthy questioned whether we should raise the sewer rate to actually fund operations rather than slowly ratcheting up the sewer rate. (28 cents vs. 40 cents sewer rate increase).

#### Case # 17-0007 - Weiss Commercial Properties, LLC - 163/165 Easy Street

Special Use Permit for Outdoor Activities and Operations

Acting Chairman Creighton swore in the witness, Mr. Craig Weiss, Owner of Weiss Commercial Properties, LLC, 165 Easy St., Carol Stream, IL, 60188.

Mr. Weiss explained that he was asking for Special Use for the property he owns at 163/165 Easy St. for outdoor storage, and he would like to construct a salt bin to store salt in the winter, which would help to de-ice the Carol Stream properties, as well as the neighboring communities more efficiently as it is a central location. He stated that they also have a few trailers and trucks for their lawn care company as well.

Acting Chairman Creighton asked for questions from the audience. There were none.

Acting Chairman Creighton asked Tom Farace for the Staff Report.

Mr. Farace explained that Mr. Weiss was requesting Special Use for outdoor activities and operations. He stated that Mr. Weiss owns a lawn care company and is requesting to install a bin on the northwest corner of the rear parking lot of property, to store salt in the winter and mulch in the summer and fall, and that all material would be stored within the concrete block bin and not outside of the bin or the parking lot area. Mr. Farace stated that there were also pickup trucks and trailers used for the business that would be parked in the back parking lot as well, and there would be a personal vehicle parked in front, and that there is adequate parking for employees in conjunction with the business.

Mr. Farace stated that there was a slatted, chain link fence installed around the rear of the property for screening purposes, and there was no way to see the bin or the trailers and trucks in the rear of the property.

Mr. Farace stated that Staff is supportive of the request as long as the conditions at the end of the staff report are met.

Acting Chairman Creighton asked for questions from the Commission.

Commissioners Tucek, Christopher, and Petella had none.

Commissioner Spink asked if any equipment breakdowns would be repaired at the location.

Mr. Weiss stated that in most cases no, and that they use an offsite certified mechanic.

Acting Chairman Creighton asked Mr. Farace if they were going to re-stripe spaces adjacent to the building, for the employees, and if there would be enough spaces.

Mr. Farace stated that there were parking spaces directly adjacent to the building to the north, and a row of parking along the back, and as a condition of approval, it should be striped with the looped striping as required by the Village, and that there would be enough spaces.

Acting Chairman Creighton asked if there would be someone to shovel the excess salt and mulch.

Mr. Weiss stated that it would be kept tidy and under a tarp.

Acting Chairman Creighton asked how the tarp would be secured.

Mr. Weiss stated that bags of salt to secure the tarp, that the concrete barriers have carabineers from the tarp to the concrete, and that is was wind tested.

Commissioner Spink moved and Commissioner Petella seconded the motion to approve Special Use Permit for Outdoor Activities and Operations.

Acting Chairman Creighton reminded the applicant that the request for the Special Use Permit will go before the Village Board on Monday, April 3, 2017, at 7:30 PM for final action.

#### Case #17-0010 - Village of Carol Stream - 500 N Gary Ave

An Amendment to a Special Use Permit for Public Service Use - Governmental Office and Police Station, An Amendment to a Special Use for a PUD, Gary Corridor Review

Acting Chairman Creighton swore in the witness, Thomas Farace, Planning and Economic Development Manager for the Village of Carol Stream, 500 N. Gary Avenue, Carol Stream, IL 60188.

Mr. Farace explained that the Village Hall would be going through a major renovation and gave a presentation showing an aerial view of the Village Hall and parking lot as it currently stands. To the West of the approx. 40,000 square foot building is visitor parking, employee parking is along the south side of the property, and police is along the east side, and two access points along Hiawatha, which will remain as is.

Mr. Farace then showed the proposed site plan with the same parking and egress configurations along with the renovations which include a small garage addition and canopies to the east, 2 new main entrances on the west side of the building; the overview of the floor plan layout for the full basement which will include additional space for IT, storage, break room, and police locker room & roll call room; the main level which will contain the departments that will have most contact with the public, and pointed out the entrance with separate lobbies for Village Hall and the Police Department; and the new second floor which will hold administration, social services, employee relations, and the board room.

Mr. Farace stated that the new Village Hall will increase square footage, going from about 40,000 square feet to about 70,000 square feet.

Mr. Farace explained that the property is zoned R-3, which is a residential zoning designation, and that a governmental or public use within this district requires Special Use approval, and that it received approval as a PUD, and that the PUD has to be amended due to the extensive renovation being done to the building.

Mr. Farace referred back the site plan, explaining that for the Gary Avenue Corridor Review, anything within 400 feet of Gary Avenue is under the purview of Gary Avenue Corridor regulations, and that area includes the east parking and the building up to the drive aisle in front of the entrance at the west side of the building, including the canopies and landscaping within that area.

Mr. Farace showed the building elevations and explained that the main material would be masonry, fiber cement and metal panels, and windows on all sides with sun shades. He stated that there would be metal panel screening for any rooftop mechanical equipment. He stated that the materials would be complimentary to the area which is both industrial and residential.

Mr. Farace explained that the canopies will offer a covered area for police cars to be protected from snow and rain, providing speedier response times in case of emergency calls. He explained that the canopies would be metal clad and the metal panels would match the metal panels on the building, approximately 13 feet high, but that since the grade is slightly lower, and there is a wall along Gary Avenue, and along with existing landscaping, that the canopies would be sufficiently screened. Mr. Farace stated that Staff feels that the canopies are a good idea.

Mr. Farace showed the landscape plan, which showed additional landscaping around both the building and the property, explained the point system, and stated that 8 additional trees are being proposed along the southeast corner of the property. Mr. Farace stated that Staff felt it was important to maintain the tree line to provide additional screening of the building and mechanical units along the south side of the building, and parking lots and canopies. Mr. Farace stated that the trees, along with the existing fence that is along the south side of the property, is an appropriate screening mechanism.

Mr. Farace stated that the Staff report listed an exemption from the provision in the PUD code that requires a certain number of landscape points for the property, and that we are short points for what is required in the code, but that staff thought that the additional shade trees and landscaping proposed to screen the equipment was more appropriate than the smaller type of landscaping that will get more points, but would not provide adequate screening above the fence.

Mr. Farace stated that Staff is looking for a positive recommendation for the Special Use amendments and the Gary Avenue Corridor Review.

Acting Chairman Creighton asked for questions from the audience. There were none.

Acting Chairman Creighton asked for questions from the Commission.

Commissioner Petella stated that, as he sees it, the building is backward and the entrance should be on Gary Avenue.

Commissioner Spink expressed concern about the canopies being wind resistant. Commissioner Christopher stated that they would be like the canopies at a gas station.

Mr. Farace stated that they would be metal clad columns and solid like at a gas station, as Commissioner Christopher indicated.

Commissioner Spink asked about complaints from the neighboring houses south of Village Hall.

Mr. Farace stated that the Village hosted an open house for property owners in the vicinity of Village Hall, and a handful of residents came in to look at the plans and ask questions, and they didn't have concerns or issues, and all seemed to like the plans.

Commissioner Tucek asked if there has been any consideration as to moving the trees on the south east side of the lot, that Mr. Farace mentioned earlier, a little to the west to screen sight lines from the second level offices to the residents yards and homes.

Mr. Farace stated that any existing plant material in good condition would remain, and that there are existing trees that would remain and still screen this area.

Commissioner Tucek asked of there was anything we could do with the canopies, such as solar panels or rooftop greenery.

Mr. Farace stated that they would be heated.

Mr. Breinig said that a rooftop garden would be expensive and require serious structural engineering, citing the aquatic business in St. Charles that tried to have a rooftop garden and it collapsed. He said the materials were not the problem, and that the weight of the water was. He said it is a public building and the Village is trying to be mindful how the money is being spent.

Commissioner Tucek asked if communication equipment will be put into place on the building.

Mr. Breinig said that there is not much in the way of anything tall on the building, and that the police dispatches to DuComm in Glendale Heights, and that coverage doesn't require a repeater site.

Commissioner Christopher asked about the material of the parking lot.

Mr. Breinig stated that the project doesn't contemplate it being replaced because it's still within its useful lifespan, and that is on the multi-year capital plan, but that it will depend on how many cuts will need to be made for utility services, but that for the moment the Village is not anticipating replacing the parking lot as part of this project.

Commissioner Christopher asked if the project was going to be green.

Mr. Breinig said that, to his knowledge, it did not require a storm water permit because they are not doing enough disruption to the parking lot pavement to warrant it.

Acting Chairman Creighton asked, regarding the original variance for the Gary Avenue Corridor, if the Village is increasing landscaping requirement from 6.8% to not quite 10%, and if it required a variation.

Mr. Farace explained that that was for the parking lot, so that won't change and the other landscaping is geared toward the perimeter of the property, therefore either a setback area to the north and east, or the buffer area to the south, and that it is referred to as an exemption as opposed to a variation because it is a PUD.

Commissioner Christopher asked if the existing stone wall was going to stay intact and what the elevation change for the parking lot to the sidewalk was, and stated that the wall is in great shape.

Mr. Breinig said no that the grade change on the police side of the parking lot is significant, and that significant site work would have to be done to gain access off of Gary Avenue, and that the elevation change is about 4 feet.

Commissioner Petella made the motion to approve and Commissioner Christopher seconded to an Amendment to a Special Use Permit for Public Service Use – Governmental Office and Police Station, an Amendment to a Special Use for a PUD, and the Gary Corridor Review.

The motion passed.

Salt Bin, Trucks, and Trailers in the I Industrial District

Craig Weiss, owner of Weiss Commercial Properties, LLC, requests approval of a Special Use Permit for outdoor activities and operations in the form of the storage of a salt bin, trucks, and trailers in the rear of the property at 163-165 Easy Street. The applicant, who owns a landscaping business and also provides snow removal services, recently purchased the property. The applicant proposes to install a bin in the northwest corner of the rear parking lot to store salt for usage during winter months. The area will be enclosed by a six-foot tall concrete block wall, will be covered by a tarp, and will occupy three parking spaces. In addition, four pickup trucks, three enclosed trailers, and one open trailer will be stored in the rear of the property when not in use, and the rear parking area will be screened by a six-foot tall slatted chain link fence. Staff has determined that the site will provide adequate on-site parking for the use in conjunction with the outdoor storage of materials/equipment. In addition, the applicant has agreed to take care of existing property maintenance issues, including repairing/restriping the parking lot and replacing the deteriorated east driveway apron.

The staff report presenting the request, with supporting documentation, was transmitted to the Village Board with the PC/ZBA packet on March 24, 2017. At its meeting on March 27, 2017, by a vote of 5-0, the PC/ZBA recommended approval of the Special Use Permit subject to the conditions in the March 27, 2017 staff report.

If the Village Board concurs with the PC/ZBA recommendation, they should approve the Special Use Permit for outdoor activities and operations in the form of the storage of a salt bin, trucks, and trailers, subject to the conditions contained within the Ordinance, and adopt the necessary Ordinance.

Development, and Gary Avenue Corridor Review Approval

The Village of Carol Stream requests approval of an Amendment to a Special Use Permit for a Public Use for a Governmental Office and Police Station, an Amendment to a Special Use Permit for a Planned Unit Development, and Gary Avenue Corridor Review approval in conjunction with the renovation and expansion of the Gregory J. Bielawski Municipal Center.

The current Municipal Center is a one-story building with a partial basement, and is approximately 40,000 square feet in size. The proposed expanded Municipal Center will include a second story addition and full basement, which will expand the size of the building to approximately 69,298 square feet. A new entrance will be constructed on the west side of the building, and a small garage addition is proposed north of the existing sallyport on the east side of the building. Parking will remain essentially unchanged, with adequate parking provided based on Village Code requirements. Visitor parking will remain along the west side of the property, with employee parking to remain along the south and east sides of the property. Two aluminum-clad canopies are proposed in the east parking lot which will provide covered parking areas for Police vehicles. The canopies will largely be screened from view by the existing stone wall and landscaping along Gary Avenue, and by landscaping and fencing for the residential properties to the south.

All four facades of the building are also proposed to be modified. The primary material of the building will be masonry to match existing masonry material, with both fiber cement and metal panels also proposed to provide building material variety to the structure. Windows on all building facades would bring natural light into the building, and limestone accent bands and sunshades are proposed to visually break up the building facades.

Existing plant material around the perimeter of the property and within parking lot islands will remain, with new landscaping proposed around the building foundation and to screen mechanical equipment on the south side of the building. GAC regulations require landscape screening within the east and

north landscape setback areas, and within the south landscape buffer area. While landscaping requirements will be met within the east and north setbacks, an exemption is necessary for landscaping within the south buffer. Staff believes an exemption is warranted given that there will be additional shade trees installed to provide effective buffering for residences to the south, along with the existing solid wood fencing providing adequate screening along the entire southern perimeter of the property.

The staff report presenting the request, with supporting documentation, was transmitted to the Village Board with the PC/ZBA packet on March 24, 2017. At its meeting on March 27, 2017, by a vote of 5-0, the PC/ZBA recommended approval of the Special Use Permits subject to the conditions in the March 27, 2017 staff report. The PC/ZBA also approved the GAC Review.

If the Village Board concurs with the PC/ZBA recommendation, they should approve the Amendment to a Special Use Permit for a Public Use for a Governmental Office and Police Station and the Amendment to a Special Use Permit for a Planned Unit Development, subject to the conditions contained within the Ordinance, and adopt the necessary Ordinance. No Village Board action is necessary regarding the Gary Avenue Corridor Review.

On Thursday, March 23<sup>rd</sup> at 11:00 AM bids were opened for the referenced project and read aloud. The following is a summary of the bids as read;

A bid irregularity of \$1,112.40 was noted in Brother's Asphalt Paving, making the actual bid \$3,672,346.15. This had no effect on their placement or the overall bid opening.

The budget for the Flexible Pavement Project is \$3,800,000 for this year. The low bid from Plote Construction was \$701,506.78 (17%) under the engineer's estimate and \$401,838.04 (10.6%) under the budget. Bids were much lower than expected primarily due to lower fuel costs and asphalt prices 10% lower than last year. This project will be funded through the Motor Fuel Tax account, and will need to follow the Illinois Department of Transportation procedures.

Engineering staff therefore recommends the 2017 Flexible Pavement Project be awarded to Plote Construction, Inc. of Hoffman Estates at the bid unit prices proposed.

In 2004 Engineering staff tested a new product called GSB-88 to alleviate problems of slow curing time, excessive sand, and generally messy conditions from previous rejuvenator products. The new product exceeded our expectations and provided the added benefit of waterproofing and an initial black color.

The product is proprietary and is not able to be funded through IDOT Motor Fuel Tax dollars. This falls under Village Code section 5-8-14 "Contracts or Purchases Without Bid" (c) Purchases which may only be made economically from a single source. However, last year we were able to obtain quotes from two contractors that are licensed by the manufacturer to apply GSB-88. Gee Asphalt Systems from Cedar Rapids, Iowa was able to provide a quote of \$1.25 per square yard plus \$7,500 mobilization cost.

American Road Maintenance (formerly Midwest Tar Sealer Company) has provided a quote of \$1.09 per square yard for 300,000 square yards of pavement rejuvenation. This is an increase of 4 cents from last year's price per square yard, which had not changed since 2013. Although we previously awarded this project in the fall, the past few years we awarded the contract prior to summer to avoid cure problems associated with cooler weather.

The budget for Pavement Preventative Maintenance Program is in the Roadway System portion of Capital Improvement this year in the amount of \$513,000.00, leaving \$186,000 for the Pavement Patching and Preservative Sealer Projects. Engineering staff therefore recommends that the 2017 Asphalt Rejuvenator Project be awarded to American Road Maintenance at the unit price submitted for a cost not to exceed \$327,000.00 pursuant to the provisions of Section 5-8-3 (B) and Section 5-8-14 (c) of the Carol Stream Code of Ordinances.

In February 2017 the Village Board awarded the referenced project to Clean Cut Tree Service, Inc. in the amount of \$33,200.00 with a contract completion date of April 15, 2017. The contractor began on February 20, 2017 and completed the work on March 6, 2017 based on 9 working days and 2 adverse weather days. That same day staff confirmed all work was complete per the contract plans and all areas were cleaned and/or restored to its original condition.

During execution of the contract, staff noted two additional trees had fallen since the original survey was completed in October 2016. One tree was leaning on another tree previously identified for removal as "img044" on Sheet 3. The second tree was a large branch from a dead tree that was perched on a stand of buckthorn across from the downstream overflow weir for the Armstrong Park Reservoir. Both locations were easily accessed by the contractor's heavy equipment. Based on staff's estimate of both the time required and of the contractor's hourly rate using the labor and equipment present at the time of the work, the contractor's requested amount of \$400 is fair and reasonable.

The net increase is less than 2% of the original contract price and the revised contract price of \$33,600 is still 4% below the budget estimate of \$35,000.00.

Staff recommends approval of Change Order No. 1 and final payment to Clean Cut Tree Service, Inc. in the amount of \$33,600.00.

Following the recent review of proposals from building code consultants for building permit plan review, plumbing inspections, as-needed supplemental inspections and general code consulting, staff recommended the continued use of B&F Construction Code Services (B&F) as the Village's building codes consultant. The Village Board concurred with staff's recommendation at its meeting on March 20, 2017. Prior to the new fiscal year, the Village Board needs to approve new professional services agreements with B&F. The purpose of this memorandum is to request Village Board approval of updated agreements with B&F for building permit plan reviews, plumbing inspections, as-needed supplemental inspections and code consulting services in FY17/18.

We have used B&F to perform plumbing inspections for many years, and beginning in 2008, with the reorganization of the Department, B&F's role was expanded to include commercial and industrial building permit plan review. As needed, B&F has also performed commercial and industrial inspections and provided general code consulting services. Following is additional detail regarding the four types of service for which the Village has contracted with B&F:

- Building Permit Plan Reviews B&F performs plan reviews for large and/or complex commercial and industrial permit applications. Department staff make the decision as to whether an application is reviewed in-house or sent to B&F for review, based on the complexity of the project, the number of applications currently under review by in-house staff, and other workload and staffing considerations.
- 2. <u>Plumbing Inspections</u> Under Illinois law, only licensed plumbers may inspect plumbing work. As the Village does not have a licensed plumber on staff, we contract with B&F to perform all plumbing inspections.
- 3. <u>Commercial/Industrial Inspections</u> The Village has used B&F for commercial and industrial inspections on an as-needed basis. We have generally only used this service during temporary staffing shortages, and have not used this service in FY15/16 or FY16/17.

4. General Code Consulting Services – This contract enables the Village to use B&F to provide general code consulting services not directly related to a building permit application. We might use this service if we needed assistance evaluating a proposed or requested local amendment to the Building Codes, for technical analysis or research, or to obtain a professional evaluation and recommendation if we received an appeal to a decision of the Building Official.

The table below provides historic information detailing recent fiscal year expenditures for B&F's services, the number of permits reviewed by B&F, and the number of plumbing inspections performed by B&F.

With our recent recommendation to continue using B&F as our building code consultant, it should come as no surprise that we rate B&F's performance as very strong over the past year. This fiscal year, B&F has completed all plan reviews within established timeframes and we have received no complaints about the content of B&F's plan review commentaries. The Village places a high priority on having an efficient and predictable building permit process, so B&F's strong performance is very important. Regarding the cost of services, B&F's fee schedule has not changed since 2008.

As we approach the new fiscal year, the Village needs to enter into new agreements for building consultant services. The current FY budget is \$100,000, and actual expenses will come in at approximately 90% of that amount. The proposed FY17/18 budget includes \$105,000 for building code consultant services. While we would expect to be able to handle more plan reviews in-house based on the skill level and full staffing of our Development Services positions, the potential for multiple large industrial developments or redevelopments may result in significant building consultant expenditures. As a reminder, B&F's plan review and plumbing inspection charges are passed through to the permit applicant.

### RECOMMENDATION

Attached are an Independent Contractor's Agreement and proposals for consultant services from B&F Construction Code Services. Staff recommends that the Village Board authorize the Village Manager by motion to execute the

attached Proposals for Professional Services and Independent Contractor's Agreement, and a purchase order with B&F Construction Code Services for consultant services not to exceed \$105,000 in aggregate during FY17/18.

### INDEPENDENT CONTRACTOR'S AGREEMENT

THIS AGREEMENT entered into by and between <u>B & F Construction Code Services</u>, Inc, herein referred to as the "First Party"; and the VILLAGE OF CAROL STREAM, 500 North Gary Avenue, DuPage County, Illinois, hereinafter referred to as the "Second Party".

WHEREAS, "First Party" will be performing various work under contracts with the said "Second Party" entered into and to be entered into from time to time, which work will be performed on and/or off the premises of the "Second Party" and said "First Party" may have subcontractors or one or more employees engaged in the performance of said work:

**NOW, THEREFORE,** in consideration of the mutual covenants and agreements herein contained, and other good and valuable consideration received and to be received, the "First Party" hereby agrees:

- 1. To comply with all laws, regulations and rules promulgated by any Federal, State, County, Village and/or other governmental unit or regulatory body now in effect or which may be in effect during the performance of the work to which reference is made above. Included within the scope of the laws, regulations and rules referred to in this paragraph but in no way to operate as a limitation, are all forms of traffic regulations, public utility and Intrastate and Interstate Commerce Commissions regulations, Workmen's Compensation Laws, Prevailing Wage Laws, the Social Security Act of the Federal Government and any of its titles, FEPC or FEOC statutory provisions and rules and regulations.
- 2. To protect, indemnify, hold and save harmless and defend the "Second Party" against any and all claims, costs causes, actions and expenses, including but not limited to attorney's fees incurred by reason of a lawsuit or claim for compensation arising in favor of any person, including the employees or officers or independent contractors or subcontractors of the first and second parties, on account of personal injuries or death, or damages to property occurring, growing out of, incident to, or resulting directly or indirectly from the performance by the "First Party" hereunder, whether such loss, damage, injury or liability is contributed to by the negligence of the "Second Party" whether latent or patent, or from other causes whatsoever, except that the "First Party" shall have no liability or damages or the costs incident thereto caused by the sole negligence of the "Second Party".
- 3. To keep in force, to the satisfaction of the "Second Party", at all times during the performance of the work referred to above, Commercial General Liability Insurance and Automobile Liability Insurance with Bodily Injury limits of not less than \$1,000,000 and Property Damage Insurance with limits of not less than \$1,000,000. The "First Party" agrees that at any time upon the demand of the "Second Party" proof of such insurance coverage as will be submitted to the "Second Party". There shall be no additional charge for said insurance to the "Second Party".
- 4. To maintain all records and documents for projects of the Public Body of the Village of Carol Stream in compliance with the Freedom of Information Act, 5ILCS 140/4 et seq. In addition, Contractor shall produce, without cost to the municipality, records which are responsive to a request received by the Public Body under the Freedom of Information Act so that the Public Body may provide records to those requesting them within the timeframes required. If additional time is necessary to compile records in response to a request, then Contractor shall so notify the Public Body and if possible, the

Public Body shall request an extension so as to comply with the Act. In the event that the Public Body is found to have not complied with the Freedom of Information Act, based upon Contractor's failure to produce documents or otherwise appropriately respond to a request under the Act, then Contractor shall indemnify and hold harmless, and pay all amounts determined to be due including but not limited to fines, costs, attorney fees and penalties.

- 5. To furnish any affidavit or certificate, in connection with the work covered by this agreement as provided by law.
- 6. To indemnify "Second Party" for any loss it may sustain by theft or other cause from the acts or negligence of the employees of the "First Party" or of the subcontractors.
- 7. To the extent required by law, Contractor agrees to comply with the provisions of the Employment of Illinois Workers on Public Works Act ("Act"). In the event the Contractor is found to have not complied with the Act, then Contractor shall indemnify and hold Public Body harmless and pay all amounts determined to be due including but not limited to fines, costs, attorneys' fees and penalties.

IT IS MUTUALLY UNDERSTOOD AND AGREED that the "First Party" shall have full control of the ways and means of performing the work referred to above and that the "First Party" or his/its employees, representative or subcontractors are in no sense employees of the "Second Party", it being specifically agreed that in respect to the "Second Party", the "First Party" bears the relationship of an independent contractor.


Transmitted with this memorandum is an ordinance establishing water and sewer rates effective May 1, 2017.

As recommended in the Water and Sewer Fund budget workshop meeting on March 20<sup>th</sup>, a rate increase for water (\$0.32 per 1,000 gallons) and sewer (\$0.40 per 1,000 gallons water used) is needed to fully cover operating costs of the Fund for the upcoming May 1, 2017 to April 30, 2018 fiscal year. The combined \$0.72 rate increase will result in an increase in the monthly water/sewer bill of a customer using 6,000 gallons of water of \$4.32.


As indicated, we have been drawing from reserves for a number of years to complete capital improvements and rehabilitations of system infrastructure assets. While this is an acceptable use of Fund reserves, these balances are declining and will not be available much beyond the forecast 3 year financial plan. The 3 year financial plan still relies heavily on reserve balances (rather than current rates) to complete scheduled capital improvements.

As you are aware, even considering the proposed rate adjustments for May 1, Carol Stream continues to have among the lowest combined water and sewer rates among DuPage Water Commission communities.

### ORDINANCE NO. \_\_\_\_\_

## AN ORDINANCE AMENDING SECTION 13-3-13 OF THE VILLAGE CODE PERTAINING TO WATER AND SEWER RATES

WHEREAS, the Village of Carol Stream owns and operates a combined water and sanitary sewerage system that serves all residents and businesses in the Village of Carol Stream and some of the adjacent unincorporated areas; and

WHEREAS, all of the funds required for the operation, maintenance and improvement of the system come from the users of the system, essentially through a system of user rates and charges; and

WHEREAS, the Village's proposed Water and Sewer Fund Budget for the new fiscal year beginning May 1, 2017 through April 30, 2018 projects that anticipated revenues to be generated from current water and sewer rates will be insufficient to cover proposed operating expenses necessary to maintain the water and sanitary sewer systems in good working order; and

WHEREAS, an increase in the water rate of \$0.32 per 1,000 gallons billed to Carol Stream water customers is necessary to offset the Village's costs of maintaining a safe and reliable potable water distribution system; and

WHEREAS, an increase in the sanitary sewerage rate of \$0.40 per 1,000 gallons of water billed is necessary to ensure sufficient funds are generated to meet the continued operational and maintenance costs of the sanitary sewerage collection and treatment systems,

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF CAROL STREAM, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: That Section 13-3-13 of the Village Code of Ordinances,
Subsections (B), (C) and (D) of the Village of Carol Stream pertaining to Water and
Sewer Rates is and the same is hereby amended to read as follows:

### §13-3-13 RATES

(B) For each residential single-family, commercial or industrial user of the combined waterworks and sewerage system within the corporate limits, the charge for water and sewer service shall be as follows:

The charge shall be \$11.07 per each 1,000 gallons or a fraction thereof.

(C) For each residential single-family and multi-family, commercial, or industrial user of water service only, within the corporate limits, the charge for water service only shall be as follows:

For each 1,000 gallons, the charge shall be \$7.25 per each 1,000 gallons or fraction thereof.

(D) For each residential single-family and multi-family, commercial or industrial user of the sewer service only, within the corporate limits, the charge for sewer service only shall be as follows:

For each 1,000 gallons, the charge shall be \$3.82 for each 1,000 gallons or fraction thereof.

SECTION 2: All other sections of the code not herein modified or changed shall remain in full force and effect.

SECTION 3: After its passage, approval and publication in pamphlet form as provided by law, this Ordinance shall be in full force and effect for usage beginning May 1, 2017.

AN ORDINANCE APPROVING A SPECIAL USE PERMIT TO ALLOW FOR OUTDOOR ACTIVITIES AND OPERATIONS IN THE FORM OF THE STORAGE OF A SALT BIN, TRUCKS, AND TRAILERS IN THE I INDUSTRIAL DISTRICT (WEISS COMMERCIAL PROPERTIES, LLC, 163-165 EASY STREET)

**WHEREAS**, Craig Weiss of Weiss Commercial Properties, LLC, hereinafter referred to as the Petitioner, has petitioned the Village of Carol Stream for a Special Use Permit to allow for outdoor activities and operations in the form of the storage of a salt bin, trucks, and trailers in the I Industrial District, as provided in Section 16-10-2(B)(14) of the Carol Stream Code of Ordinances, on the property legally described in Section 2 herein and commonly known as 163-165 Easy Street, Carol Stream, Illinois; and

**WHEREAS**, pursuant to Section 16-15-8 of the Carol Stream Code of Ordinances, the Combined Plan Commission/Zoning Board of Appeals held a public hearing on the above petition on March 27, 2017, following proper legal notice of said public hearing, after which the Commission recommended to the Mayor and Board of Trustees of the Village that the Special Use Permit be approved; and

**WHEREAS,** the Combined Plan Commission/Zoning Board of Appeals has filed its Findings and Recommendations regarding the Special Use Permit with the Mayor and Board of Trustees, and the Mayor and Board of Trustees have duly considered said Findings and Recommendations.

The Mayor and Board of Trustees of the Village of Carol Stream, after examining the Petition for the Special Use Permit to allow for the outdoor storage of a salt bin, trucks, and trailers, and the Findings and Recommendations of the Combined Plan Commission / Zoning Board of Appeals, have determined and find that the requested Special Use Permit:

- 1. Is deemed necessary for the public convenience at the location. Weiss Commercial Properties is a new business to Carol Stream, and the landscaping and snow removal business can be viewed as beneficial to the public.
- 2. Will not be unreasonably detrimental to or endanger the public health, safety, morals, comfort or general welfare. The concrete block bin and slatted chain link fencing will properly screen the salt storage bin and vehicles from Easy Street. Therefore, this outdoor activity should not be detrimental to or endanger the public health, safety, morals, comfort, or general welfare.
- 3. Will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminish and impair property values within the neighborhood. Other industrial properties have received Special Use approval for outdoor activities and operations for the storage of equipment, vehicles, and materials that were properly screened, with no apparent

injury to the use or enjoyment of properties in the immediate vicinity, or diminution or impairment to property values within the neighborhood.

- 4. Will not impede the normal and orderly development and improvement of surrounding property for uses permitted in the district. *The surrounding properties are already developed. This criterion is not applicable.*
- 5. Will provide adequate utilities, access roads, drainage and other important and necessary community facilities. Adequate utilities, access roads, drainage and other public improvements are already in place.
- 6. Will conform to the applicable regulations of the district in which it is located, except as the Village Board may in each instance modify such regulations. The proposal is expected to conform to all applicable codes and requirements.

#### **SECTION 2:**

The Special Use Permit, as set forth in the above recitals, is hereby approved and granted to Weiss Commercial Properties, LLC, subject to the conditions set forth in Section 3, upon the real estate commonly known as 163-165 Easy Street, Carol Stream, Illinois, and legally described as follows:

LOT 9 IN GARY-ST. CHARLES BUSINESS PARK, BEING A SUBDIVISION OF PART OF THE NORTHEAST QUARTER OF SECTION 5, TOWNSHIP 39 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JUNE 24, 1980 AS DOCUMENT NO. R80-35893 AND CERTIFICATE CORRECTION RECORDED OCTOBER 10, 1980 AS DOCUMENT NO. R80-62291, IN DUPAGE COUNTY, ILLINOIS







FINAL PUD PLAN







GROUND LEVEL PLAN





#### **BACKGROUND**

In December 2015, the Village Board approved a ten-year agreement with OMI for operation, maintenance and management of the Water Reclamation Center (WRC). The initial agreement year covered the period from May 1, 2016 through April 30, 2017. The agreement included a provision for annual review of costs by the Village and OMI, including a formula for a default increase should the Village and OMI fail to reach agreement.

I have worked with OMI staff to review the various cost centers included in the base fee and to develop a Capital Expenditure ("CapEx") program for the coming fiscal year. The attached proposal requests an increase to the base fee (which covers operating expenses) of 2.15% for the period May 1, 2017 through April 30, 2018, which is in keeping with the formula prescribed in the Agreement. The CapEx category will remain at \$125,000 as established by the Agreement. Starting with the new Agreement year, an additional amount of \$11,185 will be added to reflect the new rental fees for the ComEd transfer switch that was replaced last fall. This amount will be included in the Agreement each year, but will not be subject to an annual increase. As a result, the combined operating and capital budget increase would total \$46,445 (from \$1,765,013 to \$1,811,458.28).

#### **RECOMMENDATION**

It is recommended that the Village Board approve Amendment No. 1 to the Agreement for Operations, Maintenance and Management Services of the Water Reclamation Center in the amount of \$1,811,458.28 for the period May 1, 2017 through April 30, 2018.

In December of 2011 the Village received \$1,875,000 in Surface Transportation Program funding to construct a path along Gary Avenue. Then in March of 2012 we combined DuPage County's pedestrian-railroad crossing improvements with the Village's Gary Avenue multi-use path project and established DuPage County as the lead agency for engineering, land acquisition and construction of the project. Much of the last five years have been used to obtain the Phase I engineering approvals from IDOT, and fulfilling the ICC legal requirements for the railroad crossing at Gary Avenue and the Chicago, Central and Pacific Railroad.

A majority of the earthwork and retaining walls for the project were done as part of the Gary Avenue reconstruction. As part of this work, many of the required easements were obtained during the roadway project. However, it also became apparent that some property owners opposed the project and would not grant easements. The Village agreed to obtain property rights through its eminent domain powers and the County agreed to reimburse the Village for the costs of acquisition.

The attached Intergovernmental Agreement establishes responsibilities for the County and Village regarding construction in the Town Center, grant of temporary and permanent easements from the Village, and future maintenance by DuPage County for pavement markings and trail signage. The Village Attorney and Engineering staff have reviewed the attached IGA and found it acceptable. It is therefore recommended that the Village Board approve the IGA with DuPage County for the Gary Avenue Multi-Use Path.

This Intergovernmental Agreement (hereinafter referred to as "AGREEMENT") is entered into this \_\_\_\_\_\_\_\_\_, day of\_\_\_\_\_\_\_\_, 2017, between the County of DuPage (hereinafter referred to as the "COUNTY"), a body corporate and politic, with offices at 421 North County Farm Road, Wheaton, Illinois and the Village of Carol Stream (hereinafter referred to as the "VILLAGE"), a municipal corporation, with offices at 500 North Gary Avenue, Carol Stream, Illinois. The COUNTY and the VILLAGE are hereinafter sometimes individually referred to as a "party" or together as the "parties."

#### RECITALS

WHEREAS, the COUNTY in order to eliminate the existing gap in the continuity of the bike trail/route system proposes to construct an asphalt multi-use path along CH 23/Gary Avenue from the Great Western Trail to Army Trail Road and along CH 11/Army Trail Road from Gary Avenue to Brighton Drive in addition to a sidewalk along the north/south sides of Army Trail Road generally between the Chicago, Central & Pacific Railroad and 84<sup>th</sup> Court, Section No. 11-00237-11-BT (hereinafter referred to as "PROJECT"); and

WHEREAS, the COUNTY and the VILLAGE desire to cooperate in the construction of this PROJECT because of the benefit of the PROJECT to the residents of DuPage County, the VILLAGE and the public; and

WHEREAS, the COUNTY has determined that the acquisition of temporary construction easements and permanent easements from the VILLAGE are required for the PROJECT; and

WHEREAS, the COUNTY and VILLAGE are empowered to enter into this AGREEMENT pursuant to the authority granted in the Intergovernmental Cooperation Act, 5 ILCS 220/1, et seq., the

Local Government Property Transfer Act and in Article VII, Section 10, of the Illinois Constitution of 1970.

WHEREAS, the COUNTY by virtue of its power set forth in the "Counties Code" (55 ILCS 5/1-1001 et seq.) and the "Illinois Highway Code" (605 ILCS 5/1-101 et seq.) and the VILLAGE by virtue of its power set forth in the "Illinois Municipal Code" (65 ILCS 5/1-1-5) are authorized to enter into this AGREEMENT; and

WHEREAS, the COUNTY has determined that the acquisition of property, including land in fee, permanent easements and temporary construction easements (Land Acquisition), is necessary and required for this PROJECT and the COUNTY has previously, by Ordinance (ODT-\_\_\_\_\_\_), declared the need for said Land Acquisition; and

WHEREAS, the COUNTY and VILLAGE shall work collectively on said Land Acquisition; and

WHEREAS, the VILLAGE, can condemn property for a multi-use path under its home rule authority as well as its statutory authority, 65 ILCS 5/11-61-1 and 65 ILCS 5/11-61-2; and

WHEREAS, if the COUNTY is unable to reach an agreement with a property owner for the sale of property necessary for the PROJECT, the VILLAGE agrees to condemn said property through eminent domain in order to accomplish the PROJECT; and

WHEREAS, the COUNTY and the VILLAGE are municipalities as defined in Section 1 (c) of the "Local Government Property Transfer Act," 50 ILCS 605/1(c); and

WHEREAS, Section 2 of the Local Government Property Transfer Act, 50 ILCS 605/2, authorizes a municipality, pursuant to a resolution passed by a two-thirds vote of the members of its corporate authority, to convey real estate to a municipality for any municipal or public purpose of the transferee municipality; and

WHEREAS, if the VILLAGE condemns property for the PROJECT, the VILLAGE agrees to convey the interest acquired in said property to the COUNTY for the PROJECT; and

WHEREAS, the parties desire to establish the parties' costs and responsibilities with respect to the PROJECT; and

WHEREAS, the COUNTY and the VILLAGE have determined that it is in their mutual best interests to enter into this AGEEMENT.

NOW, THEREFORE, in consideration of the premises, the mutual covenants, terms, and conditions herein set forth, and the understandings of each party to the other, the parties do hereby mutually covenant, promise and agree as follows:

#### 1.0 INCORPORATION

- 1.1. All recitals set forth above are incorporated herein and made part thereof, the same constituting the factual basis for this AGRREMENT.
- 1.2. The headings of the paragraphs and subparagraphs of this AGREEMENT are inserted for convenience of reference only and shall not be deemed to constitute part of this AGREEMENT or to affect the construction hereof.

#### 2.0 SCOPE OF PROJECT

- 2.1. The PROJECT includes but is not limited to the construction of a multi-use path for public use along the west side of CH 23/Gary Avenue from the Great Western Trail to Army Trail Road and along CH 11/Army Trail Road from Gary Avenue to Brighton Drive in addition to a sidewalk along the north/south sides of Army Trail Road generally between the Chicago, Central & Pacific Railroad and 84<sup>th</sup> Court to eliminate the existing gap in the continuity of the bike trail/route system.
- 2.2. The PROJECT includes the land acquisition of property along CH 23/Gary Avenue and CH 11/Army Trail Road, in fee, permanent easements and temporary construction easements as set forth in the attached Exhibit A.

#### 3.0 RESPONSIBILITIES - JOINT

3.1. The COUNTY and the VILLAGE agree to cooperate in and make every effort to cause the construction of the PROJECT.

#### 4.0 RESPONSIBILITIES OF THE COUNTY

- 4.1. The COUNTY shall act as the lead agency and be responsible for completing all preliminary and design engineering, permit processing, utility coordination, and construction engineering for the PROJECT.
- 4.2. Both the COUNTY and VILLAGE agree that the COUNTY shall oversee the contract for the construction of the PROJECT. The COUNTY agrees to oversee the PROJECT in the best interest of both parties and to consult with, and keep advised, officials of the VILLAGE regarding the progress of the PROJECT and any problems encountered or changes recommended.
- 4.3. The COUNTY shall submit the Pre-final Plans and Specifications for the PROJECT to the VILLAGE for review. The VILLAGE shall provide review comments within fourteen (14) days of receipt of the Pre-final Plans and Specifications. The COUNTY will correct any errors and address other reasonable comments prior to the submittal of Final Plans and Specifications to the VILLAGE.
- 4.4. The COUNTY shall notify the VILLAGE, in writing, if it is unable to reach an agreement with a property owner on the sale of property located within the jurisdictional boundaries of the VILLAGE when said property is necessary for the PROJECT and request the Village to acquire the property through eminent domain.
- 4.5. The COUNTY shall pay the VILLAGE 100% of all VILLAGE's total costs associated with any eminent domain action filed to acquire property for this PROJECT, (the Land Acquisition Costs). Such Land Acquisition Costs shall include but not be limited to filing fees; attorney's fees, costs and expenses; and consultant and expert witness fees, costs and expenses and shall be payable within sixty (60) days of the receipt of invoices from the VILLAGE.
- 4.6. The COUNTY shall pay the VILLAGE 100% of the total Land Acquisition Costs as provided in Section 4.5 above whether such Land Acquisition occurs or not or whether such Land Acquisition occurs by a

determination of just compensation through the eminent domain action or through settlement with the property owner. Such costs shall be payable within sixty (60) days of the date the VILLAGE provides written notice to the County of such costs incurred.

- 4.7. In the event that the COUNTY determines that any eminent domain action should be abandoned, the COUNTY shall provide notice, in writing to the VILLAGE. The COUNTY shall be responsible for any and all costs, fees, attorney's fees, litigation expenses and other taxable costs as may be ordered by the court. Such costs shall be paid within sixty (60) days of the date the VILLAGE provides notice to the COUNTY of such costs incurred.
- 4.8. In the event that the Court orders the payment of any costs, fees, attorney's fees, litigation expenses or other taxable costs of the land owner, such costs shall be paid within sixty (60) days of the date the VILLAGE provides notice to the COUNTY of such order.
- 4.9. The COUNTY shall reimburse the VILLAGE for pass through consultant plan review and inspection fees concerning the stormwater permit as referenced in Paragraph 5.1 hereinafter.
- 4.10. The COUNTY shall, as a part of construction of the PROJECT, remove three (3) existing VILLAGE ornamental lights and return them to an area designated by the VILLAGE for future use. Additionally, three (3) existing ornamental lights will be relocated closer to the proposed VILLAGE's path connection at the COUNTY's proposed trail along Gary Avenue. One (1) ornamental light head will be rotated in order to better illuminate the VILLAGE's existing brick path. The VILLAGE also acknowledges that the VILLAGE's brick pavers being removed as a part of the PROJECT are not salvageable.

#### 5.0 RESPONSIBILITIES OF THE VILLAGE

5.1. The VILLAGE agrees to waive VILLAGE administration fees for plan/stormwater permit reviews/inspections for the PROJECT. This waiver shall not include pass

- through consultant plan review and inspection fees, for which the COUNTY will reimburse the VILLAGE.
- 5.2. The VILLAGE hereby grants to the COUNTY, its employees, contractors and agents a right-of-entry for ingress and egress onto, over, under and above VILLAGE property within the boundaries of the PROJECT for the purpose of constructing the PROJECT, provided however, that the VILLAGE shall retain the right of ingress and egress over said areas. The COUNTY's construction of the PROJECT shall not unreasonably interfere with the public purpose of the Village's property without the approval of the Village. Upon completion of the PROJECT, the right-of-entry for construction purposes shall terminate.
- 5.3. Simultaneously with the approval of this AGREEMENT, the VILLAGE shall grant to the COUNTY, at no cost to the COUNTY, temporary construction easements attached hereto as Exhibit B and permanent easements attached hereto as Exhibit C and incorporated and made a part hereof.
- 5.4. Within fourteen (14) calendar days of receiving written notice from the COUNTY that eminent domain is necessary, the VILLAGE agrees to use its home rule and statutory authority to take such actions as are necessary to acquire the property by eminent domain in accordance with the provisions of the Illinois Eminent Domain Act, 735 ILCS 30/1-1 et seq. The VILLAGE shall prosecute the eminent domain action to completion unless the COUNTY authorizes a settlement of the eminent domain action.; and
- 5.5. The VILLAGE agrees to keep an accurate accounting of all reimbursable costs pursuant to this AGREEMENT and to submit those costs to the COUNTY within sixty (60) days of incurring said costs for payment.
- 5.6. Within twenty eight (28) calendar days of the VILLAGE receiving title to the property necessary for the PROJECT, the VILLAGE shall convey said title to the COUNTY under the Local Government Property Transfer Act, 50 ILCS 605/2, and VILLAGE shall comport with all legal requirements of said statute.

#### 6.0 MAINTENANCE

- 6.1. It is understood and agreed by the parties hereto that this AGREEMENT is intended to address the PROJECT and no changes to maintenance and/or jurisdiction of existing roadways, right-of-ways and appurtenances are proposed.
- 6.2 The COUNTY will own, operate and maintain the completed PROJECT except as hereinafter referenced below.
- 6.3 The COUNTY and the VILLAGE shall be responsible for maintenance of their respective jurisdictional legs of the highways and/or streets within the PROJECT limits including all pavement markings.
- 6.4 All existing and new trail facing signage shall be maintained and installed by the COUNTY. All existing and new cross-street facing stop signs and cross-walk striping shall be maintained and erected by the COUNTY. Any cross-street facing advanced warning signage shall be maintained and installed by the VILLAGE. Said signage and striping shall be installed to conform to the FHWA "Manual on Uniform Traffic Control Devices."

#### 7.0 INDEMNIFICATION

7.1. The COUNTY shall, to the extent permitted by law, indemnify, hold harmless and defend the VILLAGE, its officials, officers, employees, and agents from and against all liability, claims, suits, demands, proceedings and action, including costs, fees and expense of defense, arising from, growing out of, or related to, any loss, damage, injury, death, or loss or damage to property resulting from, or connected with, the COUNTY's negligent or willful acts, errors or omissions in its performance under this AGREEMENT to the extent permitted by law. The COUNTY does not

hereby waive any defenses or immunity available to it with respect to third parties.

- 7.1.1. The COUNTY and the VILLAGE acknowledge that the COUNTY has made no representations, assurances or guaranties regarding the COUNTY's or any successor's or assign's authority and legal capacity to indemnify VILLAGE as provided for in this AGREEMENT. In the event a court of competent jurisdiction holds that the COUNTY, or any successor or assign, is deemed to lack the lawful authority or ability to indemnify, defend or hold harmless the VILLAGE, or any person or entity claiming a right through VILLAGE, or in the event of change in the laws of the State of Illinois governing COUNTY's or any successor's or assign's indemnification authority, such occurrence(s) shall not affect the validity and enforceability of the remainder of this AGREEMENT or the parties rights and obligations provided for therein.
- 7.2. The VILLAGE shall, to the extent permitted by law, indemnify, hold harmless and defend the COUNTY, its officials, officers, employees, and agents from and against all liability, claims, suits, demands, proceedings and action, including costs, fees and expense of defense, arising from, growing out of, or related to, any loss, damage, injury, death, or loss or damage to property resulting from, or connected with, the VILLAGE's negligent or willful acts, errors or omissions in its performance under this AGREEMENT to the extent permitted by law. The VILLAGE does not hereby waive any defenses or immunity available to it with respect to third parties.
  - 7.2.1. The COUNTY and the VILLAGE acknowledge that the VILLAGE has made no representations, assurances or guaranties regarding the VILLAGE's or any successor's or assign's authority and legal capacity to indemnify COUNTY as provided for in this AGREEMENT. In the event a court of competent jurisdiction holds that the VILLAGE, or any successor or

assign, is deemed to lack the lawful authority or ability to indemnify, defend or hold harmless the COUNTY, or any person or entity claiming a right through COUNTY, or in the event of change in the laws of the State of Illinois governing VILLAGE's or any successor's or assign's indemnification authority, such occurrence(s) shall not affect the validity and enforceability of the remainder of this AGREEMENT or the parties rights and obligations provided for therein.

- 7.3. Nothing contained herein shall be construed as prohibiting the COUNTY or the VILLAGE, its officials, directors, officers, agents and employees, from defending through the selection and use of their own agents, attorneys and experts, any claims, suits, demands, proceedings and actions brought against them. Pursuant to Illinois law, 55 ILCS 5/3-9005, any attorney representing the COUNTY, under this paragraph or paragraph 7.1, who is not already an Assistant State's Attorney, is to be appointed a Special Assistant State's Attorney, as provided in 55 ILCS 5/3-9008. The COUNTY's and the VILLAGE's participation in their defense shall not remove their duty to indemnify, defend, and hold each other harmless, as set forth above.
- 7.4. Neither party waives, by these indemnity requirements, any defenses or protections under the Local Governmental and Governmental Employees Tort Immunity Act (745 ILCS 10/1 et seq.) or otherwise available to it, or to the other party, under the law.
- 7.5. The VILLAGE's and COUNTY's indemnification under Section 7.0 hereof shall terminate when the PROJECT is completed and the VILLAGE and COUNTY assume their maintenance responsibilities as set forth in Section 6.1 hereinabove unless the injury occurred during the term of the PROJECT.

#### 8.0 GENERAL

8.1. No later than fourteen (14) days after the execution of this AGREEMENT, each party shall designate a representative to the other party who shall serve as

the full time representative of said party during the carrying out of the PROJECT. Each representative shall have authority, on behalf of such party, to receive notices and make decisions relating to the work covered in this AGREEMENT. Representatives shall be readily available to the other party.

8.2. This AGREEMENT may be executed in two (2) or more counterparts, each of which shall be deemed an original and all of which shall be deemed one in the same instrument.

### 9.0 ENTIRE AGREEMENT

9.1. This AGREEMENT represents the entire AGREEMENT between the parties with respect to the PROJECT, and supersedes all previous communications or understandings whether oral or written.

### 10.0 NOTICES

10.1. Any notice required hereunder shall be deemed properly given to the party to be notified at the time it is personally delivered or mailed by certified mail, return receipt requested, postage prepaid, or sent by confirmed facsimile or email, to the party's address. The address of each party is as specified below; either party may change its address for receiving notices by giving notices thereof in compliance with the terms of this subsection.

- 13.2. The forum for resolving any disputes concerning the parties' respective performance, or failure to perform, under this AGREEMENT, shall be the Judicial Circuit Court for DuPage County.

### 14.0 SEVERABILITY

14.1 In the event, any provision of this AGREEMENT is held to be unenforceable or invalid for any reason, the enforceability thereof shall not affect the remainder of the AGREEMENT. The remainder of this AGREEMENT shall be construed as if not containing the particular provision and shall continue in full force, effect, and enforceability, in accordance with its terms.

### 15.0 FORCE MAJEURE

15.1 Neither party shall be liable for any delay or nonperformance of their obligations caused by any contingency beyond their control including but not limited to Acts of God, war, civil unrest, strikes, walkouts, fires or natural disasters.

### Raffle License Application:



Since 2004, Alpine Amusement Co. (Naperville) has been licensed to provide carnival/amusement programming at the Ross Ferraro Town Center as part of 'Summer in the Center' events. Alpine Amusement Co. is proposing to host a 4-Day summer carnival scheduled for Friday, September 1<sup>st</sup> – Monday, September 4<sup>th</sup>. The terms detailed in the proposed carnival agreement are consistent with those from prior years and are highlighted below:

**Revenue Sharing Thresholds:** 

25% (\$1-\$50,000) 30% (\$50,001 +)

**Concession Booth Fee:** 

\$125/booth @ 8 - 10 booths

Last year's stand-alone carnival operated successfully with targeted support for traffic management and patron security by Police volunteers. Revenue from both booth concession fees and ride ticket sales generated from the carnival is programmed into the General Corporate Fund. The net revenue share to the Village from 2016 carnival proceeds was \$14,966.70 which is 30% more than 2015.

The fee structure for all carnival rides has remained the same for several years, as costs have increased Alpine Amusements has increased or added the following fee categories:

Because of the successful working relationship with Alpine Amusement Co. over the past 13 years as well as the popularity of the carnival, I recommend entering into a contract for carnival services from September  $1^{st} - 4^{th}$  per the terms detailed in the attached agreement.

This agreement made this 17th day of March, 2017, by and between Alpine Amusement Co., Inc., Party of the First Part and The Village of Carol Stream, Party of the Second Part. Second Part agrees to furnish a location for the erection and operation of a combination of rides, shows and concessions known as Alpine Amusement Co., Inc. Party of the Second Part also agrees to furnish and pay for any Village tax, permits or licenses that my be required for operation, and for all water, lot and street privileges necessary for operating, conducting, and placing of all attractions and concessions (the location must be mutually agreeable and acceptable to both parties).

Party of the First Part further agrees to furnish all electrical connections, sufficient electrical generators and electric current with distribution necessary for the power and illumination of all rides, shows and concessions. Said current to be for operating hours and to be supplied until all attractions are dismantled at the close of the engagement. Party of the First Part also agrees to furnish Uniformed Ride Attendants, Foreman on Festival grounds at all times, All ticket boxes and coupons for ride admittance and \$1,000,000 public liability and property damage certificate of insurance for each incident. (Alpine Amusement Co. is not liable for your employees and volunteers), unless caused by our own negligence. Said Certificate of Insurance shall be sent to the Village at least three (3) weeks prior to the engagement. The Village of Carol Stream, its Officers, and Employees shall be named as an insured on said policy. Said policy shall be on an ISO approved form and shall not include any limitations of liability for failure to notify the Village of the cancellation of said policy. Party of the First Part has the right of first refusal for the next year or the next year Party of the Second Part runs the festival in the event a year or more is skipped between running the festival.

Party of the Second Part also agrees to have location, portable toilet facilities available Monday before event. If streets are used for location of said attractions, Party of the Second Part agrees to have them closed to traffic and parking no later than 12:01 A.M. Monday before event.

IN CONSIDERATION OF THE ABOVE, Party of the First Part agrees to furnish, present and operate rides, concessions, and attractions as well as parking lot attendants for patron parking and vehicle security at The Ross Ferraro Town Center for a period of 4 days, starting Sept 1, 2017 and ending Sept 4, 2017 for an event to be known as 2017 Summer in the Center. To pay the Second Part the sum of \$125 for each food or concession or game booth operated on the grounds during the engagement. Any concession or booth closed or unable to operate shall pay pro rata for actual days operated. To pay the Party of the Second Part (25% from \$0-\$50,000 and 30% from \$50,001 and over) the gross receipts from monies derived from the sale of admission tickets at any attractions and rides after usual Government Taxes, Midway Insurance and State and City sales tax and amusement tax, if applicable, are deducted.

The settlement of the concessions and booths, and the percentage on the attractions and rides shall be made on the closing of the engagement. This agreement is fully assignable by Alpine Amusement Co., Inc. only upon concurrence by the Village of Carol Stream.

2017 Summer in the Center is responsible for the following services:

- \*The handling for all festival advertising and promotion
- \*Sufficient police protection and security
- \*Trash receptacles for midway clean-up operation

Party of the Second Part agrees to indemnify and hold harmless the Party of the First Part for any defects relating to the condition of the grounds. Party of the First Part agrees to indemnify and hold harmless, Party of the Second Part against any and all injuries or claims for damages as a result of said carnival, amusement and /or concessions operated by Alpine Amusements or its subcontractors or agents.

It is understood and agreed that there shall be no other riding devices, shows, attractions, or concessions (including confections to be known as popcorn, cotton candy, funnel cakes, corn dogs, sno cones, nachos, coke and other soft drinks at this event other than those furnished by Alpine Amusement Co., Inc. except those furnished by the Party of the Second Part or food vendors operating under agreement by the Village (and those agreed upon, prior to the event).

Ride selections will be based on available space and selection between the Village of Carol Stream and Alpine Amusement Co., Inc. Layout of the rides and concession booths will be determined when the snow subsides and access to the grounds is available. Appropriate measurements and walk through is required by Alpine Amusement Co., Inc. to provide accurate ride selection.

Alpine Amusement Co., Inc. agrees to comply with Village Ordinance No. 2002-06-35, regulating carnivals.




