Police Pension Fund - Compliance Report FY17:

The Village Board received the Annual Compliance Report from the Police Pension Fund as required by Public Act 95-950.

2018 Residential Solid Waste Collection Rate Schedule:

The Village Board approved an increase of 3% on the monthly refuse rates and a hold on the 2018 proposed rates through 2019 in exchange for a five year contract extension through 2024.

Ordinance No. 2017-12-73 Approving and Adopting a Revised Discriminatory Workplace Harassment Policy:

The Village Board approved amendments to the Code of Ordinances and employee Personnel Policy Manual to comply with Public Act 100-0554 and its requirements pertaining to sexual harassment policies.
