Activities and Operations, Special Use Permit for Truck Repair, Special Use Permit for Parking Lots for Motor Vehicles Not Incidental to a Permitted Use, Zoning Code Variations, Fence Code Variations / Case Nos. 21-0006 and 21-0007

Requests for Special Use Permits and Variations were originally scheduled for review at the April 26, 2021 Plan Commission/Zoning Board of Appeals meeting for Midwest Star Group at 130 and 180 Easy Street, and were continued to the May 10, 2021 PC/ZBA meeting to allow additional time to modify plans for the 180 Easy Street parcel. Additional time is still needed on the project. Therefore, staff recommends that the case be continued to the May 24, 2021 PC/ZBA meeting.
