The following are brief descriptions of those items approved on the Consent Agenda for this meeting.

Award of Contract for the 2013 Flexible Pavement Project:

The Village Board approved award of contract for the 2013 Flexible Pavement Project to Arrow Road Construction Co. in the amount of \$2,394,924.42. This contract was \$930,075.58 (28%) below the engineer's estimate and budget for this project.

Pond Shoreline and Wetland Maintenance for FY2013/14, Recommendation to Waive Bids and Award Contract:

The Village Board authorized waiving the formal bid process and awarded the 2013-14 Pond Shoreline and Wetland Maintenance Contract to Bedrock Earthscapes, LLC in the amount of \$23,015.00.

Request from the Carol Stream Park District for Temporary Variations from the Sign Code:

The Village Board approved the Carol Stream Park District request of special event signage for their "Just Play" event to be held the weekend of May 18-19.

Regular Bills and Addendum Warrant of Bills:

The Village Board approved the payment of the Regular Bills dated April 1, 2013 in the amount of \$890,728.16. The Village Board approved the payment of the Addendum Warrant of Bills from March 19, 2013 – April 1, 2013 in the amount of \$491,673.13.

Non-Consent Agenda Items

Ordinance No. 2013-04-08, Amending Chapter 11, Article 2 of the Carol Stream Code of Ordinances by Increasing the Number of Class P Liquor Licenses from 0 to 1 (Carol Stream BP, 105 W. North Avenue):

Trustee Weiss pulled this item from the consent agenda because he previously did not vote in favor of allowing package liquor sales at gas stations. Trustee Schwarze moved and Trustee McCarthy made the second to approve Ordinance No. 2013-04-08, amending Chapter 11, Article 2 of the Carol Stream Code of Ordinances by increasing the number of Class P liquor licenses from 0 to 1 (Carol Stream BP, 105 W. North Avenue). The results of the roll call vote were as follows:

Report of Officers:

Trustee Frusolone stated she and seven other Citizen Emergency Response Team (CERT) members attended the 22^{nd} annual Advanced Severe Weather seminar in Naperville which was hosted by the DuPage County Office of Homeland Security and Emergency Management. She stated the National Weather Service has updated their reporting procedures and will be issuing Impact Based Reporting which is more detailed than previous storm reports. She reminded everyone that April is tornado awareness month.

Trustee Manzzullo reminded everyone that local elections will take place one week from tomorrow (Tuesday) and encouraged people to vote. He asked everyone to remember and pray for our troops.

Trustee Schwarze encouraged all residents to please shop Carol Stream.

Trustee McCarthy stated the 4^{th} of July Parade Committee will be holding multiple fund raisers over the next couple of weeks including the following: Culvers on April 24-10% of food sales donation; Zanies Comedy Night with Mike Toomey as the headliner on May 23-\$20 ticket price donation; Flip-Flops on June 10-10% of food sales donation. The Rotary is sponsoring a community wide food drive with the drop-off being on Saturday April 13 from 11:00 a.m. -4:00 p.m. at Glenbard North High School. Further information can be gotten by emailing Luanne info@carolstreamchamber.com. He reminded everyone to please call 911 to report any suspicious activity in their neighborhoods. The calls can be done anonymously.

Village Attorney Rhodes stated Assistant Village Attorney Jason Guisinger's wife gave birth to a baby boy and that is where he is tonight taking care of mom.

Village Manager Breinig stated there will be a budget hearing at our next Board meeting on April 15. The draft budget can be viewed on the Village website, library and at the Village Clerk's office. On April 20 the Village will be hosting its annual electronics recycling event at the Town Center from 9:00 a.m. – Noon. The Park District will also be holding an Earth Day event on this date from 10:00 a.m. – 2:00 p.m. Finally, in addition to the Village of Carol Stream not having a property tax it also does not have any debt (except for a small revolving loan from the EPA on the treatment plant).

Mayor Saverino thanked State Representative Ives for attending the Village Board meeting and for providing an update on legislative issues in Springfield.
