Updated Eligibility List – Received.

OLD BUSINESS:

Commissioners reviewed an updated meeting and written examination date request for the upcoming entry-level testing schedule based on information that a neighboring agency was also administering a written examination for police officer on the original recommended date. A new meeting date of 2/9/21, and a new written examination date of 2/19/21 was confirmed.

NEW BUSINESS:

Commissioners reviewed change recommendations to the Board of Fire and Police Rules and Regulations regarding entry-level police officer hiring, as well as a function clarification regarding Officers of the Board and their duties. A synopsis of the changes as follows:

• Clarification that the function of maintaining documents is handled through the Village's Human Resources department on behalf of the Board of Fire and Police Commission with minutes held in the Village Clerk's Office.

- Addition of cannabis to the habitual use section to extent that performance may be diminished on the job as a discretionary disqualifier.
- Removal of the reference to firefighters as the Carol Stream Fire Protection District is governed by a separate body.
- Change in the amount of time to post the preliminary eligibility list from 20 days to 60 days after the written examination, mirroring State Statute.
- Providing further clarification that claims for preference points shall be verified.
- Amendments to the lateral-entry process as follows:
 - 1. Removal of the ambiguous language regarding candidate certification in <u>Illinois</u>: Many applicants certified in other states are able to receive reciprocity certification from Illinois upon hire.
 - 2. Removal of requirement for candidates to complete a physical agility examination: All certified candidates have already completed an academy that would have required this.
 - 3. Clarification that candidates will be removed from the list after two (2) years.
- Removal of a sentence regarding what the polygraph service will do as a function of their own processes.
- Various grammar corrections.

A motion was made by Commissioner Hoffman and seconded by Chairman Briggs to approve the amendments to the Board of Fire and Police Commissioners Rules and Regulations as presented.
