Commissioners reviewed a memo submitted by Chief of Police Holmer, along with supporting materials regarding candidate #4 from the police officer final eligibility list.

A motion was made by Secretary Hoffman and seconded by Commissioner Murcia to make the following findings of fact and to disqualify and remove candidate #4 from the eligibility list:

- Candidate answered **No** to the question "Have you ever been questioned as a suspect in or witness to a crime?" in in his applicant questionnaire.
- Candidate answered **No** to the question "Have you ever struck, injured, or otherwise made physical contact with a romantic partner?" in in his applicant questionnaire.
- The background investigation revealed contradictory information related to these questions.
- When questioned regarding the contradictory answers, candidate stated he forgot about the incident;
- Attempted deception is an automatic disqualifier; and
- Omitting material information from the application process is a discretionary disqualifier;
 and
- A police officer's credibility could be impeached by evidence of contradictory statements made during the hiring process.

That based upon these findings the candidate be disqualified for further employment consideration.

Commissioners reviewed a memo submitted by Chief of Police Holmer, along with supporting materials regarding candidate #5 from the police officer final eligibility list.

A motion was made by Commissioner Murcia and seconded by Secretary Hoffman to make the following findings of fact and to disqualify and remove candidate #5 from the eligibility list:

- Candidate answered No to the question "Have you ever been terminated, forced to resign, or resigned in lieu of being fired from any employment position?" on his original application.
- The background investigation revealed contradictory information related to this question.
- The background investigation also revealed the candidate has engaged in illegal activity within the last three (3) years.
- Attempted deception is an automatic disqualifier; and
- Being involved in any situation whether charged or not that would constitute a felony or misdemeanor involving moral turpitude under the Illinois Compiled Statutes is an automatic disqualifier; and
- Omitting material information from the application process is a discretionary disqualifier;
- A police officer's credibility could be impeached by evidence of contradictory statements made during the hiring process.

That based upon these findings the candidate be disqualified for further employment consideration.
