- Omitting material information from the application process is a discretionary disqualifier;
 and
- Failing to cooperate in the application process, including but not limited to failure to provide full and complete information is a discretionary disqualifier; and
- Involvement in any situation whether charged, convicted or not that would constitute a felony or misdemeanor involving moral turpitude under the Illinois Compiled Statues is a discretionary disqualifier.

That based upon these findings the candidate be disqualified for further employment consideration.
