1. Check Presentation to Operation Support Our Troops-America. A \$1,500 check was presented by Mayor Saverino to Bill Kohnke of Operation Support Our Troops-America, with funds generated from our Concert Series raffle ticket sales.

- 2. Swearing in Jonathan Czernek and Daniel Koeller as Police Officers. After introductions by Chief Holmer and badge pinning by family members, Mayor Saverino swore in Jonathan Czernek and Daniel Koeller as Village of Carol Stream Police Officers.

Award of Contract - 2022 Pavement Marking Project:

The Village Board approved a contract with Superior Road Striping, Inc. for the 2022 Pavement Marking Project at the bid unit prices with a total cost of \$42,420.02 pursuant to the provisions of Section 5-8-14(L) of the Carol Stream Code of Ordinances.

Services Klein Creek Streambank Stabilization-Section III Professional Agreement Amendment #3:

The Village Board approved an amendment to the Professional Services Agreement with Engineering Resource Associates, Inc. in accordance with the Village's Purchasing Procedures Policy and Section 5-8-3 of the Village Code for design engineering services in the not-to-exceed, cost plus fixed fee amount of \$30,000.00.

Motion to Approve an Agreement for Architectural Services with Kluber, Inc. for Preliminary Planning and Design, and Cost Estimating for the Public Works Facilities Phase II Improvements Project up to the amount of \$45,830.00:

The Village Board approved an Agreement for Architectural Services with Kluber, Inc. up to the amount of \$45,830.00 for Preliminary Planning and Design, and Cost estimating for the Public Works Facilities Phase II Improvements Project.

Wellness Initiative – Fitness Room Proposal:

The Village Board approved a fitness room within the Municipal Center and waived competitive bidding pursuant to Section 5-8-14 of the Village Code for an overall project cost not-to-exceed \$80,000 to be funded from the IPBC terminal reserve fund.

Resolution No. 3264 Authorizing the Execution of an Intergovernmental Agreement by and between the County of DuPage, Illinois and the Village of Carol Stream for the Mitchell Lakes Outfall Project:

The Village Board approved an Intergovernmental Agreement with the County of DuPage, Illinois regarding the Mitchell Lakes Outfall Project.

Resolution No. 3265 Declaring Surplus Property owned by the Village of Carol Stream:

The Village Board declared surplus a drinking fountain and bottle filling station located within the Public Works Center and authorization to dispose of said items.

Regular Bills and Addendum Warrant of Bills:

The Village Board approved payment of Regular Bills dated August 1, 2022 in the amount of \$849,700.50. The Village Board approved the payment of Addendum Warrant of Bills from July 19, 2022 thru August 1, 2022 in the amount of \$728,408.65.

REPORT OF OFFICERS:

Trustee Berger thanked everyone who attended tonight's meeting and respectfully shared their thoughts; reported his attendance at a recent Eagle Scout ceremony for Carol Stream and West Chicago youths; commended the Ride for John for bringing awareness to the Opioid epidemic; reported his representation of the Village Board at the Chinar ribbon-cutting event and welcomed this new establishment to Carol Stream; thanked Assistant to the Village Manager Messino for an outstanding job coordinating the Summer Concert Series; and thanked Kristin from Cutie-Patootie Photography for her assistance in photographing the concerts.

Trustee Garvey congratulated new Officers Czernek and Koeller; reiterated his conviction that he lives by the Word of God; and thanked his supporters for coming out tonight.

Trustee Zalak congratulated Officers Czernek and Koeller for being sworn in tonight; thanked Village Attorney Rhodes for explaining the law concerning removal of an elected official from office; thanked Assistant to the Village Manager Messino for the successful Summer Concert Series; explained the school bus law and requested adherence in order to keep our kids safe; asked parents to speak with their children about the danger of bullying and the need to be kind to each other; and asked that we keep the military and first responders in our thoughts and prayers.

Trustee Gieser congratulated new Officers Czernek and Koeller; thanked Assistant to the Village Manager Messino for coordinating the Summer Concert Series and asked her to report on upcoming events; announced the 50th anniversary of the St. Andrews Corn Fest on Saturday, August 6th; thanked Village Attorney Rhodes for explaining the law and where the Village stands on the issue of removing an elected official from office; and asked residents to join him as he continues to fight for inclusion in our diverse community.

Trustee Frusolone thanked Assistant to the Village Manager Messino for her work coordinating the Summer Concert Series; reported a successful 2022 National Night Out with much positive interaction between police and youth; thanked Chief Holmer, Deputy Chief Cummings and Village Manager Mellor for cooking the hotdogs for the event; welcomed Officers Czernek and Koeller; thanked everyone who came out tonight to voice their opinions and stated her belief that comments were emotional, not hateful; thanked Village Attorney Rhodes for explaining the complexities of the law; and expressed her support for the LGBTQ+ community and the hope that our Village can move forward to do what is best for the 40,000 residents we serve.

Trustee McCarthy acknowledged the public comments tonight and appreciated everyone giving their point of view in a respectful way; congratulated the Village on raising funds for both the food pantry and Operation Support Our Troops through our Summer Concert Series raffle ticket sales; congratulated Officers Czernek and Koeller, thanking them for choosing this tough yet important career; and wished everyone a good week.

Village Clerk Schwarze welcomed Officers Czernek and Koeller to the team; thanked Assistant to the Village Manager Messino for coordinating a successful Summer Concert Series; thanked the Police Department, Social Services unit, Community Outreach Center and the many volunteers who made National Night Out a success; thanked the Village for allowing the Ride for John Opioid Awareness event to be held at Town Center; reported our state insect, the Monarch butterfly, is now on the Endangered List, but expressed gratitude to the Village for making an effort to naturalize our public spaces, where she continues to see the endangered Monarch; and reminded everyone to shop Carol Stream.

Assistant to the Village Manager Messino announced the upcoming first-ever Carol Stream Fall Fest on Saturday, September 24th from 2-8:30pm with inflatables, face painters, food trucks and multiple bands performing.

Village Attorney Rhodes congratulated new Officers Czernek and Koeller; gave credit to his wife for reminding him to "try not sounding like a lawyer" when speaking to the public; and thanked the Village Board for their kind comments.

Village Manager Mellor explained the rigorous vetting process for new police officers, the long police academy training and two-year probationary training program, and assured residents that our officers are well-trained, know our culture well and will provide the highest level of service to our community.

Mayor Saverino congratulated our two new Officers Czernek and Koeller, "homegrown" in Carol Stream; reported that his wife has been very ill which has prevented him from being able to attend many events; thanked the Carol Stream Fire Department for their care and respect in rescuing her on numerous occasions; thanked everyone for their thoughts and prayers; thanked staff and Board members for representing the Village at community events; commended National Night Out for bringing people in our community together; announced the upcoming DARE Commencement at the Outreach Center for kids from the far east/south end of Carol Stream; thanked everyone who came in to speak tonight; and emphasized that Carol Stream is a loving, welcoming community in which people help each other out and respect each other despite our differences.
