2024 Roadway Drainage Improvements Project - Change Order 1:

The Village Board approved Change Order 1 in the amount of \$13,878.90 bringing the revised contract amount for this project to \$162,378.90 resulting in adding an underdrain at Brave Court and Potomac Court.

2024 Asphalt Rejuvenator Project:

The Village Board waived bids and approved a contract with American Road Maintenance at a cost not to exceed \$321,733.75 pursuant to the provisions of Section 5-8-3(B) and Section 5-8-14(C) of the Carol Stream Code of Ordinances.

2024 Crackfill Project Award of Contract:

The Village Board approved a contract with Denler Inc. in the amount of \$79,800.00 for the 2024 Crackfill Project.

2024 Pavement Patching Award of Contract:

The Village Board approved a contract with Schroeder Asphalt Services, Inc. in the amount of \$51,593.00 for the 2024 Pavement Patching Project.

Klein Creek Streambank Stabilization-Section III - Change Order No. 04 Unsuitable Streambed Material Replacement:

The Village Board approved Change Order No. 04 in the amount of \$53,370.00 for Unsuitable Streambed Material Replacement.

Klein Creek Streambank Stabilization-Section III - Change Order No. 05 Retaining Wall C Unsuitable Base:

Salt Purchase – Winter 2024/25:

Treasurer's Report:

The Village Board received Revenue/Expenditure Statements and Balance Sheet for the Month ended April 30, 2024.

REPORT OF OFFICERS:

Trustee Anselmo encouraged attendance at Geek Fest on June 15th; advised residents on how to deal with solicitors; and encouraged motorists to watch their speed while driving through our neighborhoods.

Trustee Berger had no report.

Trustee Zalak encouraged residents to support the Carol Stream 4th of July parade by patronizing local restaurant fundraisers; and asked that we keep first responders and the military in our thoughts and prayers.

Trustee Gieser stated he was proud to read the Pride Proclamation and looks forward to the Pride Concert on June 20th; encouraged residents to support the weekly 4th of July parade fundraisers; and congratulated The Red Apple on their 24th anniversary in Carol Stream.

Trustee Frusolone thanked the Village Board for its third year of sponsorship of the Pride Concert, and wished everyone a happy summer.

Trustee McCarthy described how to sign up to participate in the 4th of July parade; congratulated Sergeants Schneider and Paskevicz on their retirements; encouraged motorists to watch out for kids; wished everyone a happy Pride Month; and congratulated Village Clerk Schwarze on her new position as President of the Municipal Clerks of DuPage County.

Village Clerk Schwarze announced National Pollinator Week starting June 17th and invited residents to join her for "Work & Learn Day" at Jan Smith Park on June 8th; announced the Wayne Township Recycling event on June 8th; wished all the dads a happy Father's Day; and reminded residents to Shop and Dine Carol Stream.

Attorney Rhodes announced the end of the legislative session and gave an update. Bill passage awaiting the governor's signature included: elimination of the grocery tax; extension of cable/telecommunications local regulations; restrictions on e-cigarette marketing; and guidelines for municipal notification to residents ahead of pest spraying. Two bills that did not pass included: the crime-free housing prohibition; and regulation of hemp containing THC products, although the Village passed its own regulations last month.

Village Manager Holmer announced the Carol Stream Historical Society Open House on June 8^{th} ; congratulated all employees on their retirements and service anniversaries; reported that Fullerton Avenue will be closed at the railroad crossing from June 17^{th} - 21^{st} ; and issued a reminder that the June 17^{th} meeting will be canceled in line with the summer schedule.
