West Branch/Fair Oaks Road Bike Trail Temporary and Permanent Easement Purchase – 28W511 St. Charles Road

In September of 2014 the Village Board approved the "Local Agency Agreement for Federal Participation" to use ITEP funding to purchase temporary and permanent easements for the Fair Oaks/West Branch Bike Trail. It was estimated that \$96,000 would be required, with 50% from ITEP funds and 50% from Village and Township funds.

Since then, Santacruz Associates (the Village's property negotiator) has come to terms with the property owner for the cost to dedicate the easements, including additional landscaping costs. An offer of \$34,095.40 has been accepted and documents are ready to be recorded. After payment, the Village will receive 50% (\$17,047.70) from ITEP funds through IDOT and 25% (\$8,523.85) from the Township. One additional easement remains to be purchased from a property owner on Fair Oaks Road.

Engineering staff therefore recommends that payment of \$34,095.40 be made to:

Recommendation to Waive Bids and Award Contract.

In 2005, Engineering Staff worked with LaFayette Home Nursery to create a series of three-year plans for pond shoreline and wetland maintenance. Rather than awarding a three-year contract, it was decided to award each contract on a yearly basis. LaFayette Home Nursery went out of business in 2011.

Four years ago, engineering staff interviewed contractors to complete the unfinished work from LaFayette's contract, and decided to award the remaining work to Bedrock Earthscapes, LLC as a trial project. In order to control costs, we also awarded a separate contract to Wildland Management, Inc. to perform prairie burns.

Bedrock evaluated the condition of the vegetation, made maintenance recommendations and has done excellent work for the past four years. The work consists of high mowing, multiple herbicide applications and selective cutting. Last year also included planting trees at the northwest corner of Gary and Lies funded by another grant from Trees Forever and spreading free prairie seed from Fermi Lab.

The selection of Bedrock Earthscapes, LLC was compared to previously bid pond shoreline maintenance projects, and offered a substantial saving over preceding contractors. Engineering Staff therefore recommends that the bid process be waived, and the 2015-2016 Pond Shoreline and Wetland Maintenance Contract be awarded to Bedrock Earthscapes, LLC for \$24,710.00.

Recommend Approval: Memo of Understanding for a Detective to Participate In

the Child Exploitation Task Force with the FBI

Child Exploitation and related Human Trafficking crimes are on the rise and have become a priority of the FBI and Law Enforcement in general. Detectives have assisted the FBI during several of their investigations involving these crimes. Initial contact with the FBI reference to these types of cases involved victims originating from our town. Detectives made contact with the FBI and an extensive investigation culminated with the recovery of victims and felony charges against the subjects responsible.

The FBI subsequently requested a detective to assist them with other similar investigations that involved portions of DuPage County. When available, we have allowed a detective to assist the FBI.

Detectives did such an excellent job with these investigations that I was contacted by Larry Lapp, the Supervisory Special Agent in Charge of their Child Exploitation Task Force. Special Agent Lapp requested and received permission from his superiors to request a detective become a FBI Task Force Officer (TFO). While there are task force members from other larger municipalities working in other fields within the FBI, mainly drugs and gangs, our detective would be the first TFO for the Child Exploitation Task Force.

The priority crimes for the task force include: Child Abductions, Sexual Exploitation of Children, Contact Offenses Against Children, Trafficking of Child Pornography, International Parental Kidnapping and Other Crimes Against Children. Our detective would only be called out for investigations that involved area DuPage County victims or investigations, much like our officers involved with the DuPage County Major Crimes Task Force. A key benefit of this TFO designation is the selected detective would have immediate access to information and databases in the event of a serious incident involving a Carol Stream juvenile victim. We would be able to access resources much more quickly.

Acting as a TFO, our detective would be a sworn FBI agent while working these cases and could enforce Federal Laws if required. Another difference is the FBI would reimburse overtime costs incurred, up to \$1,400 per month as funds are available.

Attached is a memo of understanding. We maintain the right to deny that our detective participate in any investigation and to pull him from any investigation at any time. The assigned detective is a Carol Stream Police employee first, and any TFO assignment would depend on our manpower needs and case load. When the MOU is agreed upon, the FBI will forward the paperwork for the agreement of overtime payment. There is no expiration date in the MOU and can be cancelled at any time by either party.

This MOU is a great opportunity to work closely with the FBI which will result in an efficient and effective partnership when juveniles and young adults become victims of crimes against children, sex exploitation and human trafficking. I recommend that we become task force partners with the FBI.

# FEDERAL BUREAU OF INVESTIGATION CHILD EXPLOITATION TASK FORCE (CETF) Memorandum of Understanding (MOU)

#### **PARTIES**

- 1. This Memorandum of Understanding (MOU) is entered into by the following "Participating Agencies":
- a. Federal Bureau of Investigation (FBI)
- b. <u>Carol Stream Police Department (CSPD)</u>

#### **AUTHORITIES**

2. Authority for the FBI to enter into this agreement can be found at Title 28, United States Code (U.S.C.), Section (§) 533; 42 U.S.C. § 3771; Title 28, Code of Federal Regulations (C.F.R.), § 0.85; and applicable United States Attorney General's Guidelines.

#### **PURPOSE**

3. The purpose of this MOU is to delineate the responsibilities of Child Exploitation Task Force (CETF) participants, maximize inter-agency cooperation, and formalize relationships between the participating agencies for policy guidance, planning, training, public and media relations. This MOU is not intended, and should not be construed, to create any right or benefit, substantive or procedural, enforceable at law or otherwise by any third party against the parties, the United States, or the officers, employees, agents, or other associated personnel thereof. The MOU also outlines the mission and procedures for the CETF, which are described in greater detail in the Standard Operating Procedures (SOP) utilized by the CETF.

#### **MISSION**

4. The mission of the CETF is to provide a rapid, proactive, and intelligence-driven investigative response to the sexual victimization of children and other crimes against children within the FBI's jurisdiction; to identify and rescue child victims; to reduce the vulnerability of children to sexual exploitation and abuse; to reduce the negative impact of domestic and international parental rights disputes; and to strengthen the capabilities of the FBI and federal, state, local, and international law enforcement through training, intelligence-sharing, technical support, and investigative assistance.

#### **SUPERVISION AND CONTROL**

- 5. Overall management of the CETF shall be the responsibility of the Special Agent in Charge (SAC) of the Chicago Division of the FBI and/or their designee.
- 6. The SAC shall designate one Supervisory Special Agent (SSA) to supervise day-to-day operational and investigative matters pertaining to the CETF.
- 7. For the purposes of this MOU, a CETF member is considered full-time when that member is primarily assigned duties aligned with the defined priority threats that are dedicated to the mission of the CETF on a full-time basis (As a general matter, all personnel will work a minimum of 3 days to be considered full-time basis and make a two year commitment due to the specialized nature of the work and training). On a case-by-case basis, SSAs may authorize CETF members to temporarily support other priority FBI matters as necessary.

This document contains neither recommendations nor conclusions of the FBI. This document is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

- 8. Responsibility for conduct, not under the direction of the SAC or SSA, of each CETF member, both personally and professionally, shall remain with the respective agency head and each agency shall be responsible for the actions of its respective employees.
- 9. Each CETF member will be subject to the laws, regulations, policies, and personnel rules applicable to those of his or her respective agency. CETF members will be subject to a limited background check as required in order to obtain deputization under U.S.C. Title 28, Code of Federal Regulations (C.F.R.), § 0.85; and applicable United States Attorney General's Guidelines.
- FBI participants will continue to adhere to the Bureau's ethical standards, including Department
  of Justice (DOJ)/FBI regulations relating to outside employment and prepublication review
  matters, and will remain subject to the Supplemental Standards of Ethical Conduct for employees
  of the DOJ.
- 11. Each CETF member will continue to report to his or her respective agency head for non-investigative administrative matters not detailed in this MOU or SOP.
- 12. Continued assignment to the CETF will be based on performance and at the discretion of each CETF member's respective supervisor. The FBI SAC/SSA will also retain discretion to remove any member from the CETF.
- 13. The defined priority threats that are aligned with the mission of the CETFs are:

#### a. Child Abductions

- Non-ransom child abductions
- · Domestic parental kidnapping

#### b. Sexual Exploitation of Children Enterprises

- Domestic Child Prostitution
- Online Networks and Enterprises

#### c. Contact Offenses Against Children

- Domestic travel with intent to engage in illegal sexual activity with a minor
- Child Sex Tourism travel abroad to engage in commercial sexual exploitation of a child under the age of 18
- Production of Child Pornography
- · Coercion/enticement of a minor

#### d. Trafficking of Child Pornography

- Mass Distribution of Child Pornography
- Possession of Child Pornography

#### e. International Parental Kidnapping

International Parental Kidnapping

#### f. Other Crimes Against Children

 All other crimes against children violations within the FBI's jurisdiction should be investigated in accordance with available resources

#### RESOURCE CONTROL

14. The head of each Participating Agency shall retain control of resources dedicated by that agency to the CETF, including personnel, as well as the continued dedication of those resources. The Participating Agency head or designee shall be kept fully apprised of all investigative developments by his or her subordinates.

#### **REPORTS AND RECORDS**

15. All investigative reporting will be prepared in compliance with existing FBI policy. Subject to pertinent legal and/or policy restrictions, copies of pertinent documents created by each member of the CETF will be made available for inclusion in the respective investigative agencies' files as appropriate.

#### **SALARY/OVERTIME COMPENSATION**

- 18. The Participating Agencies acknowledge that this MOU does not alter the applicable law governing civil liability, if any, arising from the conduct of personnel assigned to the CETF.
- 19. The Participating Agency shall immediately notify the FBI of any civil, administrative, or criminal claim, complaint, discovery request, or other request for information of which the agency receives notice, concerning or arising from the conduct of personnel assigned to the CETF or otherwise relating to the CETF.
- 20. In the event that a civil claim or complaint is brought against a state or local officer assigned to the CETF, the officer may request legal representation and/or defense by DOJ, under the circumstances and pursuant to the statutes and regulations identified below.

#### **DURATION**

- 21. The term of this MOU is for the duration of the CETF's operations, contingent upon approval of necessary funding, but may be terminated at any time upon written mutual consent of the agency involved.
- 22. Any Participating Agency may withdraw from the CETF at any time by written notification to the SSA with designated oversight for investigative and personnel matters or program manager of the CETF Program (FBI HQ) at least 30 days prior to withdrawal.
- 23. Upon termination of this MOU, all equipment provided to the CETF will be returned to the supplying agency/agencies. In addition, when an entity withdraws from the MOU, the entity will return equipment to the supplying agency/agencies. Similarly, remaining agencies will return to a

- 24. Modifications/amendments to this MOU and corresponding SOP shall be brought in writing to the attention of each Participating Agency.
- 25. Participating Agencies and their assignees are bound by the terms of the MOU and SOP, as modified from time to time, although a Participating Agency may terminate its participation with the CETF pursuant to the terms related to the SOP.
- 26. Participating Agency will not be bound by any amended terms of the MOU or SOP during notice period (currently 30 days) required by the MOU prior to terminating participation.

As you know, the Village strives to maintain just and equitable compensation and benefit packages when compared against both external and internal data. The process in determining annual recommendations includes:

- Evaluating the Village's economic position.
- Evaluating salary and benefit data of comparable communities against the salaries and benefits of Village of Carol Stream positions
- Evaluating internal union settlements
- Evaluating the Consumer Price Index and Employment Cost Index
- Making recommendations based on the above data

Unfortunately, with regard to a general wage adjustment, the threat that the State of Illinois will reduce our LGDF revenue by 50% or more has left some gaping holes in available data to consider. First, while the Village's current economic position is good, that could change substantially if the State of Illinois takes our LGDF monies<sup>1</sup>. In addition, this threat has caused many municipalities to freeze discussions of a general wage adjustment until actions by the State are known, thus eliminating a significant amount comparable compensation data to analyze. Finally, all three (3) of the Village's represented employees have contracts that expire April 30, 2015. As a result, there is no internal equity data to consider at this time either.

Based on this lack of information, it is recommended that the determination of a general wage adjustment be deferred until additional data becomes available. It is anticipated that it will be several months before affirmative action is seen by the State legislature. Similarly, it is believed that available internal data (i.e.: union settlements) will also become more clear over time. As this information becomes available, an informed decision with regard to a general wage adjustment can then be brought forward.

With regard to performance based compensation, a strong majority of our comparable communities (90%) continue to provide this type of increase. In addition, internal comparability continues to allow for step increases for all other employee groups covered by a collective bargaining agreement. Therefore; it is recommended to continue to fund the performance based

 $<sup>^1</sup>$  50% of the Village's LGDF revenue equates to 7.5% of operating revenue or \$1.9 Million.

compensation program at a set 2% adjustment for this fiscal year. This recommendation allows for both internal and external equity while maintaining a conservative financial approach. It should also be noted that that the cost for these merit based adjustments are fully funded in the proposed FY15-16 budget, regardless of the current concern that the State of Illinois will reduce our LGDF revenue by 50%.

Based on a review of all other comparable benefits, no other changes are recommended for this fiscal year. Please let me know if you have any questions.

## AN ORDINANCE APPROVING A SPECIAL USE PERMIT TO ALLOW AN OUTDOOR SEATING AREA ANCILLARY TO A RESTAURANT IN THE B-2 ZONING DISTRICT (MANHATTAN'S AMERICAN BAR & GRILL, 300 S. SCHMALE ROAD)

**WHEREAS**, Sindy Rogers, hereinafter referred to as the Petitioner, has petitioned the Village of Carol Stream for a Special Use Permit to allow an outdoor seating area ancillary to a restaurant in the B-2 Zoning District, as provided in Sections 16-9-3(C)(16) and (17) and Section 16-9-4(C)(1) of the Carol Stream Code of Ordinances, on the property legally described in Section 1 herein and commonly known as 300 S. Schmale Road, Carol Stream, Illinois; and

WHEREAS, pursuant to Section 16-15-8 of the Carol Stream Code of Ordinances, the Combined Plan Commission/Zoning Board of Appeals at regular meetings thereof, held a public hearing on the above petition on April 13, 2015, following proper legal notice of said public hearing, after which by a vote of 6 - 0 the Commission recommended to the Mayor and Board of Trustees of the Village that a Special Use Permit be approved; and

**WHEREAS,** the Combined Plan Commission/Zoning Board of Appeals has filed its Findings and Recommendations regarding the Special Use with the Mayor and Board of Trustees, and the Mayor and Board of Trustees have duly considered said Findings and Recommendations.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF CAROL STREAM, DU PAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

#### SECTION 1:

The Mayor and Board of Trustees of the Village, after examining the Petitions for a Special Use Permit for an outdoor seating area and the Findings and Recommendations of the Combined Plan Commission / Zoning Board of Appeals, have determined and find that the requested Special Use Permit:

- 1. Is deemed necessary for the public convenience at the location. The applicant is attempting to expand the existing restaurant and offer the outdoor dining experience as requested for many years by its customers. Outdoor seating is a common amenity offered by many restaurants to grow business and enhance the dining experience. This use would serve the public convenience.
- 2. Will not be unreasonably detrimental to or endanger the public health, safety, morals, comfort, or general welfare. Provided that employees are properly trained, as required, and proper care and supervision is provided in the service of alcoholic beverages, the requested Special Use should not be detrimental to or endanger public health, safety, morals, comfort or general welfare.
- 3. Will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminish

and impair property values within the neighborhood. The restaurant is surrounded by similar uses in the business district. The restaurant with outdoor alcoholic beverage service should not be injurious to the use and enjoyment of other property in the immediate vicinity, nor substantially diminish or impair property values within the neighborhood.

- 4. Will not impede the normal and orderly development and improvement of surrounding property for uses permitted in the district. The restaurant serving alcoholic beverages and offering outdoor seating may draw additional customer traffic to the restaurant, which may be a catalyst for other improvement and property development in the area, and should not be an impediment to property improvement.
- 5. Will provide adequate utilities, access roads, drainage, and other important and necessary community facilities. Utilities and community facilities either have been or will be provided.
- 6. Will conform to the applicable regulations of the district in which it is located, except as such regulations may in each instance be modified by the Board of Trustees. The outdoor seating area is expected to operate and conform to all applicable regulations and any conditions of approval as determined by the Plan Commission and the Village Board.

#### **SECTION 2:**

A Special Use Permit is hereby approved and granted, subject to the conditions set forth in Section 3, to allow an outdoor seating area ancillary to a restaurant in the B-2 Zoning District upon the real estate commonly known as 300 S. Schmale Road, Carol Stream, Illinois, and legally described as follows:

Lot 1 in Leetz's Subdivision, being a subdivision of the south 200.0 feet of the east 650.0 feet (as measured at right angles) of the southeast quarter of the northwest quarter of Section 4, Township 39 North, Range 10 East of the Third Principal Meridian, (except that part lying easterly of the center line of State Aid Route 36 (Schmale Road), in the Village of Carol Stream, DuPage County, Illinois according to the plat thereof recorded August 22, 1977, as Document No. R77-73307.

#### SECTION 3:

The approval of the Special Use Permit granted in Section 2 herein is subject to the facility generally being designed and operated in accordance with the attached exhibits, including the Site Development Plan (Exhibit A) prepared by Engineering Resource Associates dated April 7, 2015, and Proposed Plans and Elevations (Exhibit B) prepared by Architectural Planning and Services dated April 8, 2015, and with the facility being operated and the site being maintained in accordance with the following conditions:

- 1. That bollards must be placed at such locations as to prevent a vehicle from impacting the outdoor seating area, and the bollards must be of adequate design and installation as to withstand vehicular impact;
- 2. That the landscape materials must be installed as shown on the plan and that all materials must be maintained in a neat and healthy condition, with dead or dying materials being replaced in accordance with the approved plan on an annual basis:
- 3. That all trash dumpsters and recycling containers placed outdoors must be kept within a code compliant trash enclosure, and that the enclosure gates must be closed and latched at all times, except when trash containers are being accessed by employees or emptied by the trash collection service;
  - 4. That a trash receptacle must be added within the outdoor dining area;
- 5. That four handicapped parking spaces must be provided, in accordance with the Illinois Accessibility Code requirements;
- 6. That a building permit must be obtained for the proposed trash enclosure and the parking lot maintenance work, which must include patching, sealcoating and restriping of the entire parking lot;
- 7. That parking spaces must be striped in accordance with the Village's looped striping detail;
- 8. That the restaurant and bar area must be adequately staffed by BASSET-trained Manhattan's employees and a security camera installed to ensure that the area where alcoholic beverages may be consumed will be properly monitored;
- 9. That the business and property must be operated and maintained in accordance with all applicable state, county and village codes and requirements.

#### SECTION 4:

This Ordinance shall be in full force and effect from and after passage, approval and publication in pamphlet form, provided, however, that this Ordinance is executed by the owners or such other party in interest, consenting to and agreeing to be bound by the terms and conditions contained within this Ordinance. Such execution and delivery to the Village shall take place within sixty (60) days after the passage and approval of this Ordinance or within such extension of time as may be granted in the discretion of the corporate authorities, by motion.







Acceptance of Schmale and St. Charles Road Watermain Easements

Last July the Village sent letters to 30 property owners requesting their cooperation in granting easements for the watermain replacement project. In December we followed up with a letter requesting the easements by mid-January. To date, we have received sixteen easements in return (accepted thirteen) and have three more to accept. They are listed below.

Ten of the remaining 14 easements have indicated they will grant it, but have not gotten around to it. We have been following up with phone calls and email correspondence to the remaining property owners. ComEd typically does not grant easements but rather uses a "land lease" agreement, which they are currently requesting \$3,000. Staff is continuing to negotiate with them. The remaining three have requested money or have not approved our requests.

Unfortunately, final construction drawings cannot be prepared until we are sure all of the easements can be obtained, and our window for bidding and construction this year has closed. Engineering staff is still pursuing the remaining easements and make a push to get them this summer, prepare contract documents in the fall, and bid for construction in the spring of 2016.

Engineering staff recommends the resolutions accepting these easements be approved and recorded. Additional resolutions for future easements will be brought to the Board for acceptance as they are obtained.







All work, labor, services, equipment, tools and materials to be performed, furnished or used directly or indirectly in, or in connection with, the Easement Activities, and all other matters and things to be performed, furnished or used, or expenses to be paid, under the term of this Grant of Easement, are to be at the sole expense of the

Grantee, and all such work shall be performed promptly and completed in each instance with diligence and as soon as reasonably practicable after commencement thereof. Grantee shall not cause or suffer or permit to be created any mechanics' or materialmen's liens or claims against the Grantor Property or the Easement Premises. Grantee shall defend, indemnify and hold harmless Grantor from and against any such claims or liens.

- 9. Grantee shall obtain all necessary permits and approvals and shall otherwise comply with all applicable federal, state and local laws, rules, regulations and ordinances in the conduct of the Easement Activities.

West Branch DuPage River Trail - Plat of Dedication for Fair Oaks Road

In order to relocate existing utilities that are in conflict with the construction of the West Branch DuPage River Trail Project, public right-of-way on the west side of Fair Oaks Road between Lies Road and a point north of Riviera Court needs to be granted by the Forest Preserve District of DuPage County. The portion between Jason Court and a point south of Riviera Court needs to be accepted by the Village of Carol Stream. The remaining portions will need to be accepted by the Wayne Township Road District as they are outside of the Village's corporate limits.

A previous intergovernmental agreement (IGA) between the Village, Wayne Township Road District and the Forest Preserve District was approved in 2011. In that agreement the right-of-way dedication would be no cost to the Village or Wayne Township.

The Plat of Dedication includes property on the west side of Fair Oaks Road from Jason Court to a point south of Riviera Court. (See attached). This property was previously annexed in 2005 as part of the Jason Court Subdivision per DuPage County Document R2005-08713. Engineering staff recommends that the resolution for the Plat of Dedication for Fair Oaks Road be approved accepting the right-of-way dedication from the Forest Preserve District.



Attached is a request from Village Bible Church to use the Kuhn/Birchbark detention basin for a 4 day soccer camp in July. This agreement is similar to the one approved by the Village Board last year. Participants are 1<sup>st</sup> - 6<sup>th</sup> grade students and the Church anticipates there will be approximately 25-30 participants for this summer's camp. The camp is branded as High Power Soccer sponsored by Awana Clubs International and there are 9-11 volunteers who run the camp. Participants bring their own soccer balls and they use large cones for goals and exercise drills. Children are dropped off at the church (located on Kuhn Road) and walk to the field with their coaches. They participate in soccer activities and then walk back to the church. Activities continue at the church in a traditional Vacation Bible School format.

Village Bible Church is requesting a license agreement to use the subject property for soccer camp on Monday – Thursday between the hours of 6:15 p.m. – 8:30 p.m. from July 20, 2015 – July 23, 2015. The Panther's Soccer club has indicated this agreement will not conflict with their existing license agreement to use this field as they only plan to use this field if the Shelburne detention facility field is too wet to use. The license agreement requires the Village Bible Church to hold the Village harmless and name the Village as additional insured on their insurance policy.

Attached for the Village Board's consideration is a license agreement between the Village and Village Bible Church to use the Kuhn/Birchbark detention basin for soccer camp from 6:15 p.m. – 8:30 p.m. from July 20, 2015 – July 23, 2015. This license agreement is similar to agreements we have used in the past for these types of activities (Panther's Soccer and Carol Stream Youth Cheerleading Associations).

### LICENSE AGREEMENT BETWEEN THE VILLAGE OF CAROL STREAM AND

# VILLAGE BIBLE CHURCH PERMITTING THE CHURCH TO UTILIZE VILLAGE-OWNED LAND FOR SOCCER CAMP

WHEREAS, the Village owns property generally located at the northwest corner of Birchbark Trail and Kuhn Road, commonly known as Birchbark Detention Basin (hereinafter referred to as the "Subject Property:); and

WHEREAS, Village Bible Church seeks to use Subject Property for recreational purposes for a limited period of time for a 4-day soccer camp and has determined it would be convenient to use Subject Property due to its close proximity to their Village Bible Church facility on Kuhn Road; and,

WHEREAS, the Village is willing to permit Village Bible Church, through this license agreement, to utilize the Subject Property for the purpose of hosting a summer soccer camp subject to the terms and conditions of this agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH HEREIN, the Village of Carol Stream ("Village") and Village Bible Church, do agree, as follows:

 Subject to the terms and conditions contained within this license agreement, Village Bible Church may utilize the Subject Property for soccer camp as follows:

Soccer Camp: 1 week from July 20 thru July 23, 2015 Monday thru Thursday, 6:15 p.m.-8:30 p.m.

2. Village Bible Church shall hold harmless, defend and indemnify the Village, its officers, employees and independent contractors, against any claims, demands, suites or judgments entered against the aforesaid parties arising out of or associated in any way with activities pursuant to this license agreement. Village Bible Church shall not be responsible for any activity, which is not related in any way to programs, sponsored by or permitted to take place on the Subject Properties. Village Bible Church shall maintain a general liability insurance policy of the type and limits as contained in the attached. In addition Village Bible Church, pursuant to this agreement, shall name the village and the other parties listed above as additional insured under any general liability insurance policy to which it is a party. The obligation to hold harmless, defend and indemnify is also intended by the parties to constitute a contract sufficient to cause the implementation of any contractual liability provision contained with any insurance contract.

- 3. The use of the properties by Village Bible Church shall take place only between the hours and dates specified in Section 1 above.
- 4. Village Bible Church shall cause all litter and trash to be removed after each practice.
- 5. There will be no vehicle drop-off or pick-up of soccer camp participants at Subject Property
- 6. The license agreement fee shall be \$1.00 payable upon execution of this agreement.
- 7. At the end of the period set forth in this license agreement Village Bible Church will return the Subject Property to the Village in the same condition in which it received it, normal wear and tear excepted. In the event the use should cause a deterioration in the quality or quantity of the grass which currently covers the Subject Property, the Village, at its reasonable discretion may require Village Bible Church to re-seed and maintain those damaged portions of the Subject Property until a mature growth of grass occurs or undertake that work and bill Village Bible Church for its actual personnel, material and equipment costs.
- 8. This agreement shall expire at the end of soccer camp on July 23, 2015. Either party may cancel this license agreement upon prior written notice, but said cancellation shall not affect the obligation of Village Bible Church to hold harmless, defend and indemnify for any events, which took place during the term of the agreement.


