Chairman Angelo Christopher called the Regular Meeting of the Combined Plan Commission/Zoning Board of Appeals to order at 7:00 p.m. and directed Secretary Linda Damron to call the roll. The results of the roll call vote were:

Commissioner Spink moved and Commissioner Creighton made the second to approve the minutes of the meeting of June 9, 2014. The motion passed by unanimous voice vote.

#### **PUBLIC HEARING:**

Commissioner Joseph moved and Commissioner Spink made the second to open the Public Hearing. The motion passed by unanimous voice vote.

## Case # 13120 - Packaging Personified - 246 Kehoe Boulevard Variation - Number of Required Parking Spaces

Chairman Christopher swore in the witness, Joe Imburgia, 246 Kehoe Blvd, Carol Stream, IL 60188. Mr. Imburgia stated that he was here tonight to ask for relief from the number of required parking spaces required by the Zoning Code. He stated that Packaging Personified is a family owned business and has been in business for 35 years and has been in Carol Stream since 1987. He stated that his company is a manufacturer of flexible packaging. He explained his company's shift schedule (see staff report), stating that several of the departments will run schedules that do not put employees in the building at the same time. He stated that they have come to the conclusion that they need 65 parking spaces and the code required 134 parking spaces and they will be able to provide 116 parking spaces even with their anticipated growth of an addition to the building and additional 20 employees.

Chairman Christopher asked if anyone from the audience had any questions. There were no questions from the audience.

Chairman Christopher asked Mr. Bastian for the staff report.

Assistant Community Development Director Don Bastian gave a summary of the staff report. Mr. Bastian stated the Packaging Personified is looking to build an expansion to their building at 246 Kehoe Boulevard, and the request is to reduce the number of parking spaces required by the Zoning Code. Mr. Bastian referred to the table on page two of the staff report; he stated that the required parking spaces for this building with the building expansion are based on the use of space (office, production and warehouse) and 134 parking spaces are required by the Zoning Code. Mr. Bastian stated that as shown on the site plan the petitioner was able to design a parking lot that would provide 116 parking spaces and the petitioner is requesting a Zoning Code Variation to

provide fewer parking spaces than what is required by the Zoning Code. Mr. Bastian stated that staff looked at the petitioners operation, and found that they have a maximum of 57 employees on site during their busiest time, and with the anticipated additional 20 employees they will still have sufficient parking spaces. Mr. Bastian stated that staff feels 116 parking spaces will be sufficient. Mr. Bastian stated that there have been a few Zoning Code Variations in the past to reduce the required parking spaces, one for 258 Westgate Drive in 2008 and another in 2012 for 125-175 Mercedes Drive.

Mr. Bastian stated that staff recommends approval of the variation to reduce the number of parking spaces subject to the conditions listed on page 5 of the staff report, and with the recommendation that the Variation be granted to the business not to the property.

Chairman Christopher asked if any of his fellow Commissioners had any questions.

Commissioners Hennessey and Meneghini did not have any questions.

Commissioner Joseph wanted to know if the shift chart listed in the staff report is how they currently operate their shifts. Commissioner Joseph wanted to know if the petitioner would only see their maximum usage of parking spaces after the building expansion is built.

Mr. Imburgia stated that the shift chart listed in the staff report is a current shift schedule. Mr. Imburgia stated that they would only see their maximum usage after the building expansion is built.

Commissioner Joseph asked Mr. Bastian if there would be an opportunity in the future for more parking if needed.

Mr. Bastian stated that they could add a few parking spaces, but this property does have a rail spur that cuts through the property and it also has a wetland area.

Commissioner Spink wanted to know when the petitioner anticipates building the addition.

Mr. Imburgia stated that they anticipate building the addition this year.

Commissioner Creighton wanted an explanation on the recommendation by staff to have the Variation be granted to the business not the property.

Mr. Bastian stated if a new business would move in they may not have the same characteristics operationally, number of employees, number of shifts or they may change the use of space in the building. These factors would result in different parking characteristics, and the factors that allow staff to support Packaging Personified's request would no longer be applicable.

Chairman Christopher asked the petitioner if they agreed to the conditions listed in the staff report.

Mr. Imburgia stated that yes, they agreed to the conditions listed in the staff report.

Commissioner Spink moved and Commissioner Hennessey made the second to approve the request for a Variation for the number of required parking spaces at 246 Kehoe Boulevard subject to the recommendations listed in the staff report.

Case # 14140 - Richard Armbrust - 381 Main Place Rezoning - B-4 to B-3 Variation - Outdoor Business Vehicle Parking

Chairman Christopher swore in the witness, Richard Armbrust, 1203 Aurora Way, Wheaton, IL. Mr. Armbrust stated that his company is a fourth-generation business and has been in business for 96 years and has been serving Carol Stream and the surrounding communities since 1918. Mr. Armbrust stated that they are looking to expand the business and his company has the opportunity to purchase the building at 381 Main Place. Mr. Armbrust stated that he was here tonight to request a zoning change for the building from B-4 to B-3 and for a variation to park business vehicles outdoors. Mr. Armbrust stated that a total of nine service vehicles would be parked on property from around 3:00 p.m. to 6:30 a.m. and as part of the requirements from the village, they would install a 7' double sided fence around the rear of the property with a gate. Mr. Armbrust stated not only would the fence secure the vehicles but it would also shield the surrounding business from any visual impacts they may have.

Chairman Christopher asked if anyone from the audience had any questions. There were no questions from the audience.

Chairman Christopher asked Mr. Bastian for the staff report.

Assistant Community Development Director Don Bastian gave a summary of the staff report. Mr. Bastian stated that the petitioner has two requests; the first one being a Rezoning from B-4 to B-3 and the other request is to park business vehicles outdoors. Mr. Bastian stated that the reason for the rezoning is a Contractor's Office is not permitted use in the B-4 District, but a Contractor's Office is a permitted use in the B-3 District. Mr. Bastian stated that the surrounding properties are a mixture of zoning classifications. Mr. Bastian stated that when staff does a review of a Zoning Map Amendment there are several factors they consider; they consider the compatibility between the adjacent properties and the characteristics of the proposed use. Mr. Bastian stated that staff feels that the zoning change for this property will not be noticeable or cause any problems in the neighborhood as this property is located along a transition area between properties zoned B-2 and B-4. Mr. Bastian stated the Future Land Use Plan does recommend office use for this property. Mr. Bastian stated that staff recommends approval of the Zoning Map Amendment.

Mr. Bastian stated that the Variation for Outdoor Business Vehicle Parking is for a fleet of 9 vehicles, and the vehicles would be parked to the east behind the building. Mr. Bastian stated that what is being proposed is a solid wooden fence with a gate that would surround the rear parking area where the vehicles would be secured and screened. Mr. Bastian stated the petitioner has a plan to construct an additional driveway to improve the traffic flow on the property. Mr. Bastian stated that staff recommends the Zoning Map Amendment and the Variation for Outdoor Business Vehicle Parking subject to the conditions listed on pages 5 and 6 in the staff report.

Chairman Christopher asked if any of his fellow Commissioners had any questions.

Chairmen Christopher and Commissioners Meneghini, Hennessey, Spink and Joseph did not have any questions.

Commissioner Creighton wanted to know the number of employees that JMA Railroad Supply Company has that occupies the upper level of the building.

Mr. Armbrust stated that JMA Railroad Supply Company currently owns the building and the company has moved to Indiana and they have one office in the building with one employee.

PC/ZBA Case 13120, Packaging Personified Inc. – 246 Kehoe Boulevard Zoning Code Variation to Reduce Required Number of Parking Spaces

Packaging Personified, a manufacturer of flexible packaging products for consumer product companies nationwide operating in Carol Stream since 1987, is planning a 38,000 square foot building addition onto the east side of their existing 80,500 square foot facility at 246 Kehoe Boulevard. As part of the expansion, some existing parking spaces will be removed and the parking lot will be reconfigured. Including the 38,000 square foot addition, the Zoning Code requires 134 parking spaces based on the use of space in the building. However, due to site constraints, Packaging Personified is proposing to install only 116 parking spaces. To allow fewer parking spaces to be provided than are required by the Zoning Code, Joe Imburgia, General Manager of Packaging Personified, has filed an application for a Zoning Code Variation. In their application, Packaging Personified has demonstrated that their low overall employee count, combined with the multiple shift and production line nature of their operations, results in an actual parking demand far below the 116 spaces they propose to provide.

The staff report presenting the request, with supporting documentation, was transmitted to the Village Board with the PC/ZBA packet on June 20, 2014. At their June 23, 2014, meeting, by a vote of 6-0, the PC/ZBA recommended approval of the Zoning Code Variation to reduce required parking from 134 spaces to 116 spaces following construction of the building addition, subject to the conditions in the staff report.

If the Village Board concurs with the PC/ZBA recommendation regarding the Zoning Code Variation to reduce required parking for Packaging Personified Inc., they should approve the Variation, subject to the conditions contained within the Ordinance, and adopt the necessary Ordinance.

Armbrust Plumbing, a fourth generation plumbing, heating and air conditioning contractor's business currently operating in Wheaton, would like to purchase the property and move its operations to the building at 381 Main Place in Carol Stream. The 7,700 square foot two-level office building, currently for sale, is partially occupied by JMA Railroad Supply Company. Armbrust Plumbing's *Contractor's Office* use is not permitted within the B-4 Office, Research and Institutional Building District, which is the current zoning classification of the property. However, the use would be a permitted use in the B-3 Service District. As such, Richard Armbrust has filed an application for a Zoning Map Amendment to rezone the property from B-4 to B-3. In addition, Mr. Armbrust would like to park nine business vehicles (seven vans, one pickup truck and one box truck) within a new fenced area behind the building. As the Business District zoning regulations require all business activities to take place inside of a building, Mr. Armbrust is also seeking a Zoning Code Variation to allow for the outdoor parking of his fleet of business vehicles.

The staff report presenting the request, with supporting documentation, was transmitted to the Village Board with the PC/ZBA packet on June 20, 2014. At their June 23, 2014, meeting, by a vote of 6-0, the PC/ZBA recommended approval of the Zoning Map Amendment to rezone the property from B-4 Office, Research and Institutional Building District to B-3 Service District. The PC/ZBA also recommended approval of the Zoning Code Variation to allow for the outdoor parking of business vehicles, subject to the conditions in the staff report.

Recommendation for Purchase of Pick-up Truck

The FY15 budget includes \$37,000 (account 0167-0500-54415) for the replacement of truck #31, a medium-duty pick-up truck which serves as a street division vehicle most frequently used in support of street lights and sign maintenance. This truck is also regularly used as a snow plow throughout the winter months. Truck #31 was purchased in 2003 and currently has less than 40,000 miles on it.

As we do prior to any vehicle replacement we recently conducted an assessment of the vehicle and have determined that this truck is still in good operating condition. While there is damage to the body in several locations it does not have any significant service history. It does show some typical wear from its heavy use as a snow plowing vehicle, but overall remains in good shape. Outright replacement of this vehicle could reasonably be delayed for several budget cycles.

However, there is another vehicle in the fleet (truck #12) which serves the vehicle maintenance function and which is nearing the end of its useful life. Truck #12 is a 1997 model with over 88,000 miles on it. While its service history is typical for a seventeen year old vehicle the body is deteriorating and will require work to address rusting on both rear quarter panels and both front fenders, which may not be a prudent investment given the vehicle's age. In addition, this vehicle is not set up to handle snow plowing duties. Therefore, we are recommending that truck #12 be retired and the current truck #31 be reassigned to replace truck #12 as a fleet maintenance division support vehicle (and with availability as a snow plowing vehicle).

Furthermore we recommend purchase of a new 2015 Ford F250 supercab 4x4 pick-up truck with snowplow from Bob Ridings Fleet Sales to replace the reassigned truck #31. We have found the vehicle that meets our needs through the State of Illinois Central Management Services joint purchase contract (#4017340). Attached is a quote for the truck order in the amount of \$31,464.00. Following delivery we anticipate an additional \$1,500.00 in expenses to outfit the truck with a two-way radio, light bar, and decals, for a total cost of approximately \$33,000.00.

I recommend that the Village Board approve a Motion to purchase a Ford F250 from Bob Ridings Fleet Sales in the amount of \$31,464.00.

Recommendation to Waive Competitive Bidding and Award a Contract for

Vehicle Rehabilitation Services

The FY15 budget includes \$40,000 (account 0167-0200-54415) for the rehabilitation of a large dump truck. Staff initially targeted truck #67 since it is one of the oldest large plow trucks in the fleet, is showing signs of advanced deterioration and it does not have a wetting system. However, after examination by potential vendors it was determined that truck #67 is too far gone to make such an investment worthwhile. Therefore, we have identified another truck (#72) that is budgeted for replacement in FY17 at a cost of \$180,000.00. Our goal is to extend the life of one or more of these large trucks for at least ten years and defer a replacement cost of at least four times the rehabilitation cost.

The planned work would include services by several types of vendors, so we solicited companies interested in serving as a sort of general contractor who will oversee all of the work. This will save staff time as well as reduce the overall rehabilitation schedule through coordination of the various suppliers and services. While we attracted two vendors interested in the work, ultimately only one submitted a proposal. This vendor, Henderson Truck Equipment, has been a long-time supplier of this type of vehicle and equipment to the Village.

The work that is planned for truck #72 will include replacement of the dump body and salt-spreader with stainless-steel components, re-plumbing of the entire hydraulic system with hard stainless-steel tubing from front to back, sandblasting and re-coating of the entire underbody and snow plow, re-configuring the existing wetting system to allow us to test various methods of material-spreading that were featured at the recent North American Snow Conference, and upgrading of the salt and wet-system controls to an electronic control system that senses speed, thereby improving efficiency in these operations.

I recommend that the Village Board approve a Motion to waive competitive bidding and award a contract for truck rehabilitation services to Henderson Truck Equipment in the amount of \$39,735.00.

In 2011 several businesses along Randy Road had contacted the village to complain about parked vehicles on the north side of the street impeding access to parking lots and truck docks. Engineering and Police staffs investigated the complaint and observed large trucks parked to the edge of driveways, impeding employee's visibility and delivery driver's maneuverability.

Since then additional parking problems have developed and require Traffic Code revisions. Employees from 361 Randy Road are parking around the curve between Gerzevske Lane and Randy Road creating a sight distance problem. Drivers are also parking opposite loading docks at 430 and 500 Randy Road impeding semitrailer trucks ability to make deliveries.

Staff therefore recommends the following additions to Chapter 8: Traffic Code, Article 6: Parking Schedules, Schedule I. Parking Prohibited; Signs Required;



With the start of the County's Armstrong Park Flood Control Projects they installed no parking signs along preferred truck routes in an effort to help maintain traffic flow. These were not authorized and could not be enforced by the Village. They also created a hardship for many of the residents along these routes.

Subsequently the Village, County and their contractor have worked out an alternative access route plan that has construction traffic coming in via Thunderbird Trail and Arrowhead Trail while leaving using Illini Drive and Aztec Drive. It should be noted this is the preferred access route, but there may be instances where another route will be used.

For the most part the construction traffic coming in and going out will be split which eliminates the need for no parking signs. All the signs have been removed. However, we have observed one short section of Thunderbird Trail where two-way traffic could be hindered causing unsafe conditions if parking is allowed on either side of the street. This is the section of Thunderbird Trail from Kuhn Road to Aztec Drive. Currently parking is prohibited on the north side of the street. Staff therefore recommends the following addition to Chapter 8: Traffic Code, Article 6: Parking Schedules, Schedule I. Parking Prohibited; Signs Required;

# AN ORDINANCE APPROVING A VARIATION TO REDUCE THE REQUIRED NUMBER OF OFF-STREET PARKING SPACES IN THE I INDUSTRIAL DISTRICT (PACKAGING PERSONIFIED INC - 246 KEHOE BOULEVARD)

**WHEREAS**, Joe Imburgia, General Manager of Packaging Personified Inc., hereinafter referred to as the Petitioner, has petitioned the Village of Carol Stream for a Variation to reduce the required number of off-street parking spaces to be provided as required in Section 16-13-3 of the Carol Stream Code of Ordinances, on the property legally described in Section 2 herein and commonly known as 246 Kehoe Boulevard, Carol Stream, Illinois; and

WHEREAS, pursuant to Section 16-15-6 of the Carol Stream Code of Ordinances, the Combined Plan Commission/Zoning Board of Appeals at a regular meeting thereof, held a public hearing on the above petition on June 23, 2014, following proper legal notice of said public hearing, after which the Commission voted 6-0 to recommend to the Mayor and Board of Trustees of the Village that the Variation to reduce the required number of off-street parking spaces be approved; and

WHEREAS, in making its recommendation to approve the Variation, the Combined Plan Commission/Zoning Board of Appeals found that the total employee count of the business, and the degree to which the peak parking demand is reduced due to the multiple shift and multiple production line nature of Packaging Personified's operations, provides sufficient evidence that the business requires far fewer parking spaces than are required by the Zoning Code; and

**WHEREAS,** the Combined Plan Commission/Zoning Board of Appeals has filed its Findings and Recommendations regarding the Variation with the Mayor and Board of Trustees, and the Mayor and Board of Trustees have duly considered said Findings and Recommendations.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF CAROL STREAM, DU PAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

**SECTION 1:** The Mayor and Board of Trustees of the Village, after examining the Petition for a Variation and the Findings and Recommendations of the Combined Plan Commission/Zoning Board of Appeals, have determined and find that, with respect to the requested Variation:

- (1) That the property in question cannot yield a reasonable return if permitted to be used only under the conditions allowed by the regulations governing the district in which it is located.
- (2) That the conditions upon which the petition for variation is based would not be applicable generally to other property within the same district.
- (3) That the granting of the variation will not be detrimental to the public welfare or injurious to other property or improvements in the neighborhood in which the property is located.
- (4) That the plight of the owner is due to unique circumstances.
- (5) That the variation, if granted, will not alter the essential character of the locality.

**SECTION 2:** A Variation is hereby approved and granted to Packaging Personified, Inc., to reduce the number of off-street parking spaces required to be provided from 134 spaces to 116 spaces, subject to the conditions set forth in Section 3, upon the real estate commonly known as 246 Kehoe Boulevard, Carol Stream, Illinois and legally described as follows:






